Instructions

1. The Diploma Examination comprises three papers of 100 marks each.

The participants who will score 50 percent or more in the examinations for each module will be declared successful.

- 2. Each candidate has to submit the project report on or before 30th Jan, 2018.
- 3. Examination details:
- (i) Examination Fee for diploma examinations is Rs, 1200/- (Rupees Twelve hundred only) for all the papers OR for a single paper.
- (ii) Examination fees to be paid through Demand Draft of requisite amount drawn in favour of "the Institute of Cost Accountants of India" Payble at Kolkata
- (iii) The Diploma examinations will be held in the month of June/December. The last date for submission of application form is 31st March for June term and 30th September for December term.
- (iV) The examination is conducted at the following centers: Please refer Annexure-1
- 4. Only one Application form must be filled up given the choice of papers. Multiple Applications by the same candidate are liable to be rejected.
- 5. A candidate must write in Block Letters the name of his/her Examination Centre and the Examination Centre Code in the space provided for in the Application Form. Centre once opted for will not be changed under any circumstances. See annexure for the Examination Centre and corresponding codes.
- 6. A Candidate must send his/her application form and remittance in respect of his/her own candidature only.
- 7. Incomplete applications forms are liable to be rejected.
- 8. Request for change of Centre or Paper will not be entertained under any circumstances.
- 9. The students are advised to keep the photocopy of the Demand Draft and the filled up examination Application form with him/her before sending the same to the Institute for requirement in future for any reference.
