Sub: Clarification on applicable Sections of Companies Act, 2013 for June 2015 term of Examination

This has reference to the Circular Ref. No.: BoS(Academics)/12-01/2014-15, Kolkata, December 17, 2014 (attached herein for ready reference)

"Point No. (1) Applicability of The Companies Act, 2013.

For June 2015 and December 2015 term of Examination, <u>all the sections</u> of the Companies Act, 2013 shall be applicable."

It is observed that several sections under the Companies Act 2013, which were to be enforced, is pending enforcement till date, thereby, making a reference to the "corresponding sections of The Companies Act,1956".

Hence, clarification is issued in relation to the applicability of sections for JUNE 2015 TERM OF EXAMINATION ONLY, while for December 2015 term, the same would be clarified by October, 2015.

It is clarified that for June 2015 term of Examination, covering both Syllabus 2008 and Syllabus 2012 including subjects/papers, as applicable, there-under, shall be guided by :

Provisions Act,1956	of	The	Companies	Where provisions of The Companies Act,2013 is spelt out but is not made applicable/enforceable till date.

(2) Applicability of the Finance Act, 2014

- For June 2015 and December 2015 term of Examination, provisions of Finance Act,2014 shall be applicable. Relevant amendments will be uploaded in the website of the Institute from 25/12/2014.
- Change/amendment in any provision of the law/statute relating to Indirect Taxation (like Central Excise, Customs, Anti-dumping, Service Tax, VAT, CST, SEZ, FTP) six months prior to the month of examination would be applicable for June 2015 and December 2015 term of Examination.
