The Ministry of Corporate Affairs (MCA) has notified the Companies Indian Accounting Standards (Ind-AS) Rules 2015, which stipulates the adoption and applicability of Ind-AS in a phased manner beginning from the Accounting period 2016-17 adopted by specific classes of companies based on their Net worth and listing status. Companies can also voluntarily adopt IND AS beginning on or after April 01, 2015. However, once they have started reporting as per the IND AS, they cannot revert. Recently, RBI has deferred adoption of Ind AS by commercial banks for year (till April 2019) due to unpreparedness of banks to migrate to the new accounting system. India's new accounting standard, Ind AS 115 also came in effect on April 1, 2018 and lays down the principles to be applied by an entity in order to report useful information to users of financial statements.

Ind AS being the new language of accounting and reporting, it is essential for every professional or organisation to stay updated and enhance their accounting knowledge. **On this backdrop, the Company Law and Corporate Governance Committee of PHD Chamber is organizing Conference on Indian Accounting Standards (Ind-AS) : Transition towards Uniform Regime on Tuesday, 29<sup>th</sup> May 2018 at PHD House, New Delhi.**
