- The Bidder (ISP) should be a company registered in India under Registrar of companies (Attach a copy of Certificate).
- The Bidder (ISP) must be capable of delivering the internet protocol i.e. IPv4 as per the guidelines of Govt. of India.
- The Bidder (ISP) shall provide all the necessary hardware equipment for providing the Internet connectivity.
- The Bidder (ISP) must provide entire connectivity up to the Router/Firewall level located at the customer premises.
- The last mile connectivity shall be in Fiber/Copper.
- The place of installation is **Institute of Cost Accountants of India. CMA Bhawan. 12, Sudder Street. Kolkata – 700 016.**
- The Bidder (ISP) will required to sign service level agreement having the following clauses:
  - Required Internet bandwidth up-gradable at any time.
  - Compression ratio 1:1
  - Packet Losses: Less than 1 percent
  - Throughput Guarantee: 100 percent.
  - The time of attending the call to restoration shall not be more than 24 Hrs.
- Initially the contract would be for one year, however, if the services provided is satisfactory, the Institute may renew the contract further.
