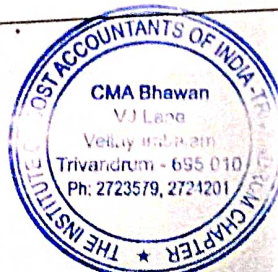

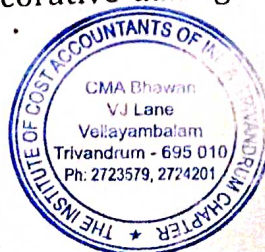

### Additional tender condition.

1. The duration of the work is 30 days from the date of receipt of Work Order.
2. Copies of valid trade licenses, permissions to be enclosed
3. The contractor shall inspect the work site & access the scope , area of the work & shall quote the rate for the work which shall be called contract amount .No additional payment would be made. Bidders are requested to visit the sites, at their own cost, to assess the quantum of work.
4. Adequate precaution shall be taken to prevent danger from electrical equipment. No materials on any of the sites of work shall be so stacked or placed as to cause danger or inconvenience to any person.
5. 1% of the contract amount will be levied per week as liquidated damages subject to a maximum of 10% for delay in completion of work beyond the stipulated period.



6. All the balance materials should be removed and cleared from the work site as soon as the concerned work is over.
7. It is entirely the contractor's responsibility to provide all safety equipments wherever necessary to their workmen. The Institute of Cost Accountants of India -Trivandrum Chapter is in no way responsible for any kind of injury, disability or death of contractor's workmen due to non-compliance of safety regulations.
8. All statutory deductions such as Income Tax, Kerala Construction Workers' Welfare Funds etc... will be made from the Contractor's bill as per rules.

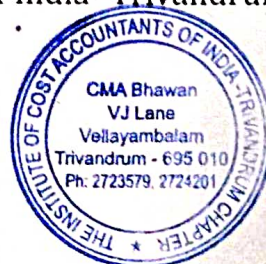
