Bhavnagar Municipal Corporation re-invited RFPs for appointment of Chartered Accountant Firm for Developing Accrual based Double entry Accounting system, Preparation of Standard Comprehensive Municipal Accounts Manual, Full Transmission of current accounting system to Accrual based system from F.Y.2016-17 to F.Y.2018-19 and Developing and/or Implementing Accounting Software.

Amendments in the re-tender document:

1. In this connection, it is announced that **Firms of ICWA (Cost Accountant Firms)** will be also eligible to apply for this re-tender with same minimum criteria of experience, financials, firm details, etc. and evaluation shall be done accordingly. They have to provide their all relevant information at various places of documents accordingly. All the Chartered Accountants may take this announcement into account please.

Further to clarify, as per pre-bid minutes of tender no.BMC/Account/2015-16/E-1, to avoid joint ventures, the firm will not be allowed to sublet/subcontract the work to any other firm at any point and time during the project period. For this re-tender, the firm has to execute the entire project by itself only.

2. **Additional Terms and conditions (if CA firm reports to develop NEW Software):**

The bidder has to include 3-tier architecture technology to the new software to be developed.

3. **Pg no.9, Point no.8 AND Pg no.10, Part-B, Point no.3 :** "The firm having **Experience of** developing and implementing such Software..." is to be read as "The firm having Experience of developing and implementing such Software or Versions for **atleast TWO** Government Organization/Department, involving Double Entry Accounting work in .NET technologies or other as per terms & conditions and SQL as a back end involving all the phases of SDLC (Software Development Life Cycle) or Own developed/customized Web Based Accounting Application **or implementing/customising/integrating Tally ERP at such Government Organization/Department according to their requirements."**
