- 5. **SSP Sale Certificate**: Certificate to the effect as and when required on monthly basis.
- 6. **No Subsidy Claim Certificate (Export)**: No subsidy claim Certificate with every lot of export sale as and when required.
- 7. In addition to the above, the documents required by the Ministry from time to time has to be certified and get audited before submission. Moreover, the data once submitted may also be revised due to change/rectification of input/output of various data.
- 8. **Supplementary Claim :** The Subsidy bills once submitted has also to be supplemented by fresh claim due to increase/decrease of Concession Price of Urea fixed by GoI from time to time or due to change of Pricing Policy by the GoI.
