#### **GENERAL TERMS**

- 01. Sealed offer is invited from reputed Chartered / Cost Accountant Firm/LLP Firm for verification and certification of unit-wise closing coal stock as on 31.3.2017 in all mines, washeries and coke plants of CIL spread over in 8 states (West Bengal, Jharkhand, MP, Odisha, Maharashtra, UP, Assam and Chattisgarh).
- 02. The complete offer document can be downloaded from CIL website at <a href="www.coalindia.in">www.coalindia.in</a> and from govt. website <a href="www.tenders.gov.in">www.tenders.gov.in</a> and also from Central Public Procurement Portal i.e. CPP-Portal. Downloaded offer document will be valid if submitted alongwith Application Fee of <a href="#">₹ 1000.00</a> (non-

refundable) in the form of Bank Draft from a RBI approved scheduled bank drawn in favour of Coal India Limited, payable at Kolkata and undertaking (in a separate envelope) that the bidder will accept the offer document as available in the website and the offer shall be rejected if any tampering in the offer document is found to be done and detected at any time after opening of bid or during pendency of the contract. CIL shall not be responsible for any delay / difficulties / inaccessibility of the downloading facility for any reason what-so-ever.

In case, less than three bids are received, tenders can be considered for opening. In case, no offer is received, tender will be cancelled with competent approval.

03. The Offer shall be submitted in two parts. Part-I shall consist of credentials (duly authenticated by the bidder) in support of his / their qualifications in accordance with the eligibility criteria as per NIO. Part − II shall consist of Price Bid, duly filling in rates, amount etc.

The Earnest Money Deposit of ₹20000/- (Rupees Twenty Thousand only) is to be submitted in a separate envelope altogether, after super scribing 'Earnest Money Deposit' and not inside the envelope containing Part − I or Part − II of the Bid. Thereafter all the envelopes should be submitted in a sealed envelope with

appropriate superscription.

- 04. The offer shall be addressed to GM (Prod), CIL and may be submitted in person by the Bidder in the Offer Box kept at Production Division, Third Floor, Office Block, Coal Bhawan, Coal India Limited, Premises No. 04 MAR, Plot No. AF-III, Action Area-IA, New Town, Rajarhat, Kolkata 700156 or sent by Post to the above address so as to reach on or before the due date and time i.e. on 2.02.2017 at 4.00 PM. CIL does not take any responsibility for loss of offer in transit. Offers sent through fax or e-mail will not be considered. Offers received at Production Division of CIL at the address given above, after due date and time of submission shall be rejected.
- 05. Name, Address, Telephone No., Fax No. and e-mail address of the Bidder alongwith such details of the contact person of the Bidder should be indicated in Form I (General Information).
- 06. Part-I (commercial bid) only will be opened at 11.00 AM on 3.02.2017 in presence of the authorized representative of the Bidder who may like to attend the Bid opening.
- 07. After scrutiny/consideration of Part-I (Commercial Bid), Part-II (Price Bid) shall be opened for those only who fulfill the eligibility criteria, for which date of opening will be communicated in due course by e-mail, apart from other modes of communication.
- 08. The complete offer should be typed in the letterhead of the bidders. If firm's letterhead is not sufficient to accommodate commercial details and if other papers are used, such sheets alongwith other pages of the offer should be signed and stamped by firm's authorized signatory. No hand written offer will be accepted.

- 09. Bidder should sign with seal on all pages of their offer including all enclosures submitted with the offer.
- 10. Quotations erased and over-written, will be summarily rejected unless corrections are authenticated with the Bidder's authorized signatory.
- 11. The offer should be submitted strictly as per the terms and conditions laid down in the offer document failing which the offer will be liable for rejection. In the event of the Bidder remaining silent on any terms and conditions of the NIO, it will be presumed that Bidder has accepted such terms and conditions.
- 12. CIL reserves the right to reject or accept or withdraw their offer in full or part as the case may be without assigning reason thereof.
- 13. Language: The language of the bid shall be in English. All documents enclosed should also be in English language. In case the original document is in a different language, self-attested English translation must be furnished.
- 14. No deviation of the terms and conditions of the offer document is acceptable. Terms and conditions which are in deviation of the offer terms will make the offer liable for rejection.
- 15. (a) A single Affidavit sworn before Notary Public as per format enclosed as Form-III has to be submitted by the Bidder. Failure to submit the above Affidavit shall disqualify the Bidder from further consideration of the bid.

On the basis of the above Affidavit, scrutiny of the commercial bid by CIL shall be made based on the information furnished by the Bidder in the commercial details without any verification of the supporting documents.

However, **Notarized copies** of all documents and statements duly stamped and signed by the Bidder, have to be submitted by the Bidder and CIL shall consider them without any verification with original. CIL will reserve the right to carry out any verification etc. at a later stage, if necessary and take suitable action against the Bidder if any information is not found to be correct or authentic.

(b) The bidder must declare that their firm has not been appointed by CIL or any of its subsidiaries as Internal Auditor and their firm will not accept any other audit job, including Internal Audit (excluding Tax audit, VAT audit and any other statutory certificates related to Audit requirements) by any subsidiary / CIL during the course of Verification and Certification of closing coal stock as on 31.03.2017 in all mines, washeries and coke plants of Coal India Limited (CIL).

Failure to submit the above Declaration shall disqualify the Bidder from further consideration of the bid.

### **COMMERCIAL TERMS & CONDITIONS**

#### 1. Scope of Work

- a. It is proposed to verify and certify the unit-wise Closing Coal Stock as on 31.03.2017 of all mines, washeries and coke plants by Chartered / Cost Accountants by examining/reconciling all relevant documents like shiftwise production report, daily production report, monthly production report, coal transfer/receipt register etc. The subsidiary-wise name and location together with other details of mine is enclosed as Annexure-B.
- b. The job shall be completed within seven working days starting from 19.04.2017.
- c. The certificate should be submitted in the proforma enclosed as Annexure-A individually for the units allotted.
- d. The above mentioned certificate along with copies of all relevant documents is to be submitted within 27.04.2017 to CGM/GM (Production/Co-ordination/Operation) of Subsidiary Company Headquarters and subsequently to GM (Production), Coal India Ltd., Rajarhat, New Town, Kolkata-700 156 alongwith acceptance certificate from CGM/GM (Production/Co-ordination/Operation) of Subsidiary Company Headquarters.

#### 2. Earnest Money/Security Deposit

The value of Earnest Money to be deposited by the bidder shall be ₹ 20000/-(Rupees twenty thousand only). Earnest Money Deposit (EMD) should be in the form of Demand Draft drawn in favour of Coal India Limited and payable at Kolkata and must accompany the commercial offer i.e. Part-I of the Bid. Offer will be rejected in case of non-submission of EMD alongwith the commercial offer i.e. Part-I of the Bid. For unsuccessful Bidder EMD shall be refunded immediately after finalisation of the offer. Earnest Money shall be forfeited if any Bidder withdraws the offer before finalisation of the offers or fails to submit offer acceptance within 7 days from the date of issue of Work-order or withdraws the offer after submission of the offer at any point of time after opening of offers. For successful bidders Earnest Money shall be released after successful completion of the job and submission of report. If a party fails to start the work within 21.04.2017, the Earnest Money stands to be forfeited without showing any reason thereof. CIL management can engage any other eligible firm for execution of that job. Earnest Money will not fetch any interest.

#### 3. Qualification Criteria

- (a) The Bidder must have at least 10 qualified Chartered / Cost Accountants who should be partners or on the roll of the firm as on 01.01.2017 and must have at least 7 qualified Chartered / Cost Accountants partners or on the roll of the firm as on 01.01.2017 having valid Certificate of Practice (COP).
- (b) A list, showing the name of qualified Chartered / Cost Accountants who are the partners or on roll of the firm as on 01.01.2017, should be certified by the firm under seal or through Notary Public. The firm should make their offer in Authorized Printed letter head, alongwith copy of valid Certificate of Practice (COP) and Registration of the firm with the Institute indicating registration number certified by Notary Public. Failure in this regard the offer will be summarily rejected immediately or in subsequent period.

#### 4. Payment Terms

Payment will be made within 21 days after acceptance of the report by the subsidiary's CGM/GM (Production/Operations/Co-ordination) and CIL (HQ) and submission of bill whichever is later.

#### 5. Paying authority

The paying authority shall be GM (Finance)/IC, Coal India Limited, Rajarhat, New Town, Kolkata-700 156. The bills should be submitted in duplicate through GM (Production), CIL. Payment will be made through e-payment.

#### 6. Service Tax

The service taxes payable should be indicated separately as applicable as per Govt. rule.

#### 7. Performance and Penalty Clause

Reports of certification of closing stock have to be submitted to CGM/GM (Production /Co-ordn /Operation) of concerned subsidiary within 27.04.2017. In the event of non-submission of report by 27.04.2017 to CGM/GM (Production /Co-ordn /Operation), of subsidiary company, 10% of the bill amount will be deducted from the bills submitted upto the period of next 7 days. Thereafter for subsequent delay of each 7 days additional 5% will be deducted subject to maximum of 20%.

#### 8. Distribution of the work

The work shall be distributed subsidiary-wise amongst 2 Bidders i.e. L-1 and L-2 Bidders, at L-1 price (which will be counter-offered to the L-2 Bidder) in

the following manner: - L-1 means the lowest Bidder against each subsidiary and L-2 means the next higher Bidder and so on.

<u>In all the cases</u> the L-2 Bidder will have to match the L-1 price to be eligible for distribution. If L-2 does not agree to match L-1 price and L-3 agrees to do so, then L-3 will be treated as logical L-2 and so on.

- (a) The ratio of distribution of work subsidiary-wise amongst L-1 and L-2 Bidders shall be 60:40 (no. of Areas) respectively, other than NCL and NEC. In case of NCL and NEC only one i.e. L-1 Bidder will be allotted the job.
- (b) In case only one Bidder i.e. L-1 is available due to absence of a L-2 or higher Bidder's unwillingness to match the L-1 rate, the entire work shall be awarded to L-1 Bidder only.
