- **3.** GUVNL may at its discretion, seek from any or all CA / ICWA Firm clarification(s) on application submitted including technical information, document and materials for empanelment.
- **4.** GUVNL reserves the right to accept or reject any application in part or full without assigning any reason whatsoever.
- 5. GUVNL may issue clarifications/amendments in the form of addendum / corrigendum during the empanelment period. CA / ICWA Firms shall take such addendum and corrigendum into consideration while submitting their application. CA / ICWA Firms are requested to visit GUVNL's website from time to time for any corrigendum/ addendum.
- **6.** Any application received by GUVNL after the scheduled closing date and time will not be accepted.
- 7. Matter relating to any dispute or difference arising out of present EOI, and subsequent contract based on the bid shall be subject to exclusive jurisdiction of courts at Vadodara only.
