- (iii) Cost of Tender document is Rs. 210.
- (iv) Service and gateway charges shall be borne by the bidders.
- (v) Since the bidders are required to sign their bids online using class-III Digital Signature Certificates, they are advised to obtain the same at the earliest.
- (vi) For further information regarding issue of Digital Signature Certificate, the bidders are requested to visit website www.mpeproc.gov.in. Please note that the process may take time for issue of Digital Signature Certificate. MPPGCL will not be responsible for delay in issue of Digital Signature Certificate.

- [3] Apart from uploading e-Tender on website, bidder has to submit separate envelope of (i) Techno-Commercial bid Contains (a) Techno commercial details (b) Certificate of acceptance of Commercial Terms (c) Compliance Certificate (d) Documents required for pre-qualification requirement (PQR) criterion. This envelope should be properly super scribed that this envelope contains Techno-commercial bid and PQR against respective Tender with due date & time of Tender opening as per NIT. This envelope should be submitted physically until date of submission and opening against the Tender. Tenders received within specified time (e-Tender as well as physical submission) shall only be opened at 16.00 Hrs. on the date specified against Tender in presence of the Tenderer or their authorized representatives, whosoever may be present.

[4] **Documents required for participation in Tender.**

- (i) The prospective bidders, who have adequate documents to fulfill criteria of credentials will upload scanned self certified copies of requisite documents as required in e-Tendering process.
- (ii) Those physically submitted documents will be acceptable and considered, if, same are uploaded on the website along with Tender offer. Cognizance of other physically submitted documents (if any) shall not be taken.
- (iii) First of all the physically submitted envelope of credentials/TENDER documents will be opened. The offers received without pre requisite credential /TENDER documents shall not be considered further for opening of their e-Tender. Decision of MPPGCL in this respect shall be final.

- (iv) The Tenders received without pre-requisite credentials shall be returned unopened to the respective bidder. The Tender fees shall not be refunded.
