1. **Qualification Criteria:**

- The firm should have been in operation for minimum of 3 years and experience of Internal Auditing, Preparation/Verification of Annual Accounts of Central Autonomous Bodies/Filing of e -TDS Returns of Income Tax, Concurrent Pre-Auditing of payments and as per scope of work and should submit financial standing of last three years.
- The firm should have valid Registration, Income Tax Permanent Account Number (PAN) and Service Tax Registration, etc to run the business.
- 2. Please note that no counter proposal is acceptable to us and conditional / late submissions of offers are liable to be rejected.
- 3. Bidders/Tenderers should enclose attested copy of VAT/Sales tax registration, PAN Number/Card and any other valid document regarding the existence and registration of the firm

If the service provided by the vendor is found unsatisfactory or if at any time during the period of contract it is found that the information provided for the contract or any claim is false or if irregularities shown by the vendor for applying for the contract, NEIGRIHMS shall reserve the right to cancel the contract and remove such vendors from empanelment /rate contract without giving any notice to the vendor.

- 13. Bid documents (RFP's or Quotation) will be issued only to the short listed applicants
- 14. The EOI shall be valid for a minimum period of one year from the date, as the tender are finalized /awarded, or till the finalization of next tender by the Institute, whichever is earlier.
- 15. Director, NEIGRIHMS, Shillong shall be the final authority to reject full or any part which is not confirming to the terms and conditions.
- 16. Agency submitting tenders would be considered and accepted all the terms and conditions. No inquiries

- 17. Any action on the part of the tender to influence anybody in the said Institute will be taken as an offence and the tender submitted by the firm will subsequently be rejected.
- 18. If at any time, any question, dispute or difference whatever shall arise between the two parties NEIGRIHMS on the one hand and agency on the other hand) in relation to the contract either of the parties may give to the other notice in writing the existence of such a question, dispute or difference and the same shall be referred to two arbitrators, one to be nominated by the firm. Either party shall serve such a notice of the existence of any question, dispute or difference in connection with this purchase within 30 days of the beginning of such dispute failing which all right or claims shall be deemed to have been forfeited and absolutely barred. Before proceeding with the reference the arbitrators shall appoint/nominate an umpire. In the event of the arbitrators not agreeing in their award the umpire appointed by them shall enter upon the reference and his award shall be binding on the parties. The venue of the arbitrator shall be at NEIGRIHMS. The provision of the Indian Arbitration and Reconciliation Act 1996 and of rules framed if under and any statutory modifications thereof shall be deemed to apply and be incorporated for the supply, installation, installation and commissioning etc. Upon every or any such reference the cost of any incidents to the reference and awards respectively shall be at the discretion of the arbitrators on in the event of their not agreeing of the Umpire appointed by them who may determine the amount thereof or direct the same to be fixed as between solicitors and client or as between parties and shall direct by whom and in what manners the same shall be borne and paid.
- 19. The courts at Shillong will have the jurisdiction to try any matter, dispute or reference between the parties arising out of the contract. It is specifically agreed that no court outside and other than Shillong court shall have jurisdiction in the matter.
- 20. Any failing of omission to carry out the provision of the contract by the agency shall not give rise to any claim by any party, one against the either, if such failure of omission or arises from an act of God, which shall include all acts of natural calamities such as fire, flood, earthquake hurricane or any pestilence or from civil strikes, compliance with any stature and/or regulation of the Government, lookouts and strikes, riots, embargoes or from any political or other reasons beyond the suppliers control including war (whether declared or not) civil war or state or insurrection, provided that notice or the occurrence of any event by either party to the other shall be given within two weeks from the date of occurrence of such an event which could be attributed to force major conditions.
- 21. In case the vendor appoints manpower / labour in excess of or equal to the number as specified by law, the agency should comply with all statutory enactments including Contract Labour Regulation and Abolition Act, 1970; Minimum Wages Act where applicable; Payment of wages Act, where applicable; ESI Act, 1948, where applicable; EPF Act, 1952, where applicable; etc. All existing statutory liabilities relating to engagement of personnel related to labour laws shall be sole responsibility of the agency.
