Background Document

A. INTRODUCTION OF THE COMPANY

RCF is one of the leading manufacturers of Fertilizers and Industrial Chemicals in India. The manufacturing facilities are located at Trombay near Mumbai and Thal in Raigad District of Maharashtra. RCF Produces Urea and Complex Fertilizers in the composition 15:15:15 and 20:20:0. Suphala, a 15:15:15 fertilizer is one of the well-known brands of RCF. The major industrial chemicals produced by RCF include Methanol, Methylamines, Sulphuric Acid, ABC, etc.

B. Maintenance of Cost Records and Cost Audit in RCF Limited.

RCF is currently covered under Companies (Cost Record and Audit) Rules, 2014 & Companies (Cost Record and Audit) Amendment Rules, 2014 issued by Central Govt under sub-section (1) and (2) of section 469 and section 148 of the Companies Act 2013.

Product and Services to be covered under the audit and the scope of cost audit shall be as per the relevant section/orders/clarifications/notifications issued from time to time by the Central Govt.

C. Number of Cost Auditors proposed to be appointed

The Company intends to empanel Two Cost Accountant (individual) or a firm of Cost Accountants as Cost auditors for period of Four years i.e. Financial Year 2017-18, 2018-19, 2019-20 and 2020-21 at the same rates, terms & conditions where the cost audit assignment would be rotated amongst them for the said periods.

2. Submission of Bids

The Bid shall be signed by the Bidder or a person or persons duly authorized by bidder. **Authorization letter** shall be enclosed as the case may be.

- 3. The Bid shall contain no erasures or overwriting except as necessary to correct errors made by the Bidder, in which case, such corrections shall be initialed and stamped by the person or persons signing the Bid in original.
- 4. Only those bidders who qualify for the Technical part (upon satisfying the Prequalification/evaluation criteria) would be eligible for empanelment and appointment as cost auditor for four Financial Years (2017-18 2018-19, 2019-20 & 2020-21).
- 5. After opening of Technical Bids no clarifications will be sought /accepted from the bidders. Further bidder shall note that no pre-qualification documents will be accepted after opening of Technical Bid. It is, therefore, requested that the bidders must ensure that their bid has all the required information and that there is no ambiguity of any kind in their offer. The evaluation would be done on the basis of the information / data provided by the bidders in the Technical bid document.
- **6.** Unsolicited bids shall not be entertained and liable to reject outright.
- 7. Incomplete bids, late received bills are likely to be rejected and no correspondence in this regard will be entertained by RCF.

- **8.** RCF reserves the right to accept or reject any tender including the lowest one, in part or full, without assigning any reason whatsoever.
- 9. Bids must be kept valid for a minimum period of 90 days from the date of opening of the bid.
- 10. While submitting the bid, tenderers are requested to ensure that bids are in compliance with the regulations applicable under various statutes. Any fine, penalty or expenses due to breach arising thereon will be borne by the tenderer; RCF will bear no financial implication on this account.

- 17. The Arbitration proceedings shall be governed by the Arbitration and Conciliation Act, 1996 or any statutory modification or re-enactment there-of and the rules made there under.
- 18. The firm hereby agrees that it shall have no objection if the arbitrator so appointed is

an employee of RCF and had to deal with the matter to which the contract relates and that in the course of his duties as such he has expressed his views on all or any of the matter in dispute or differences.

19. Further, it is agreed by and between the parties that in case a reference is made to the Arbitrator or the Arbitral Tribunal for the purpose of resolving the disputes/differences arising out of the contract by and between the parties hereto, the Arbitrator or the Arbitral Tribunal shall not award interest on the awarded amount more than the rate SBI PLR/Base Rate applicable to RCF on the date of award of contract.

20. Jurisdiction
