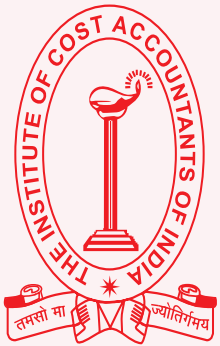

I am also grateful to our new recruiters, who have acknowledged the potential of our students and provided them with a plethora of professional opportunities.

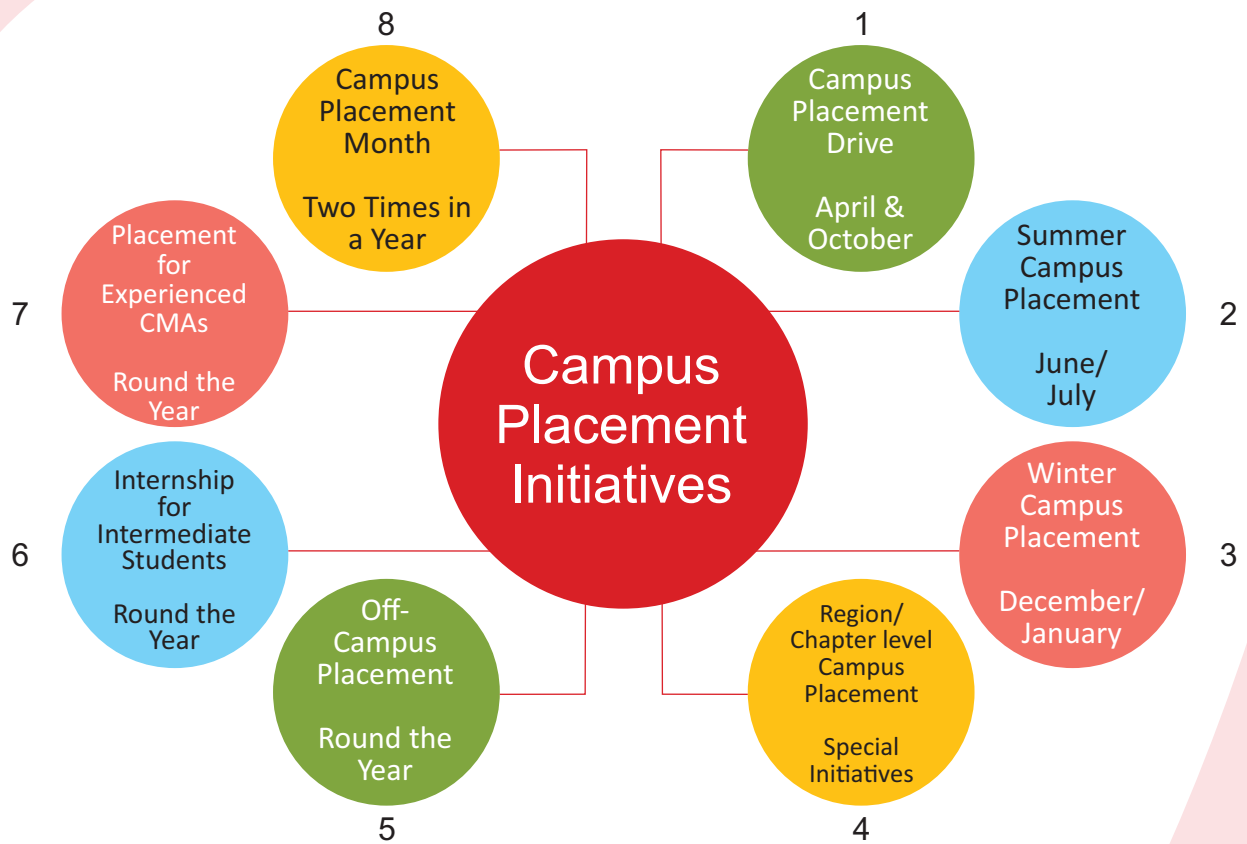

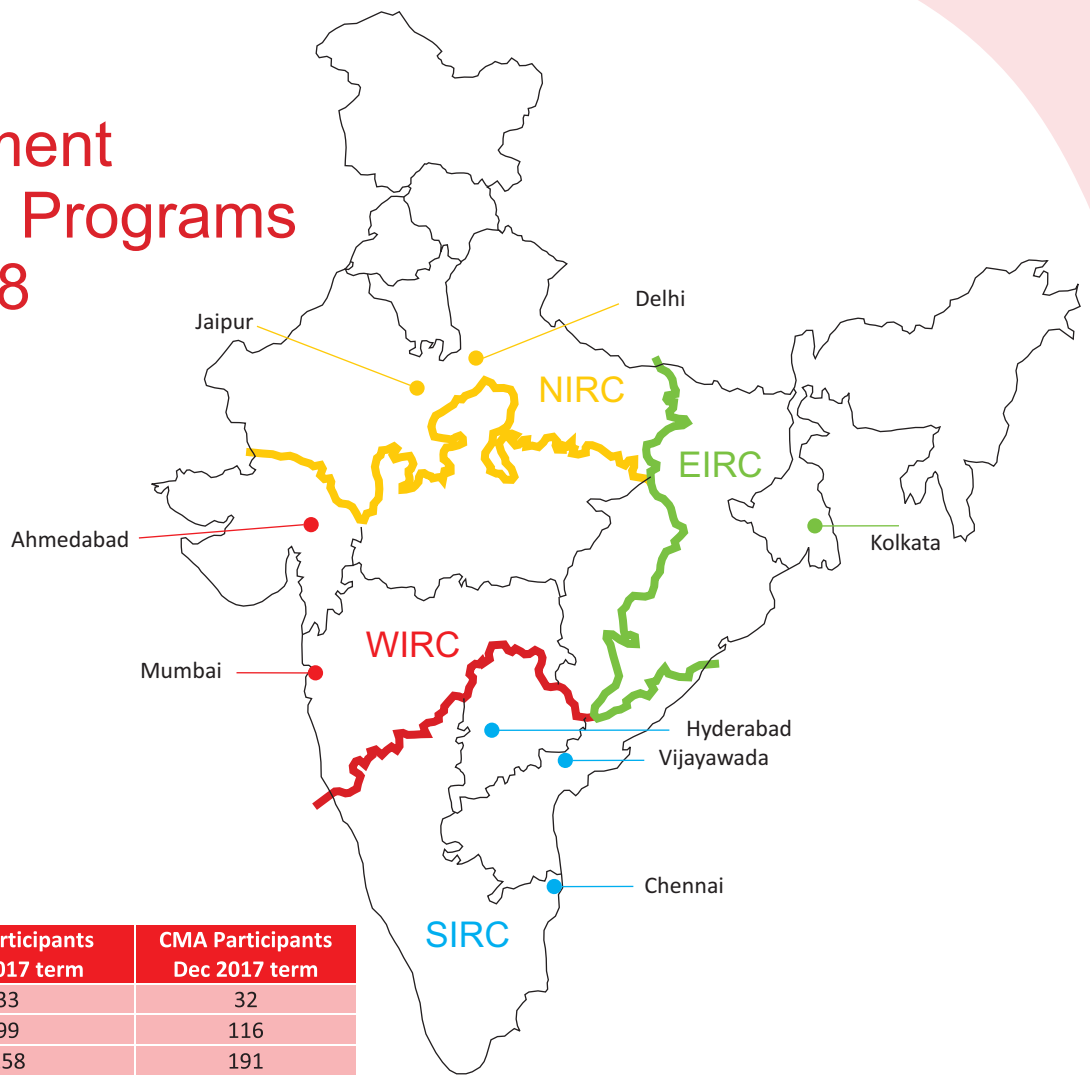


## Prominent Recruiters - 2017 - 2018

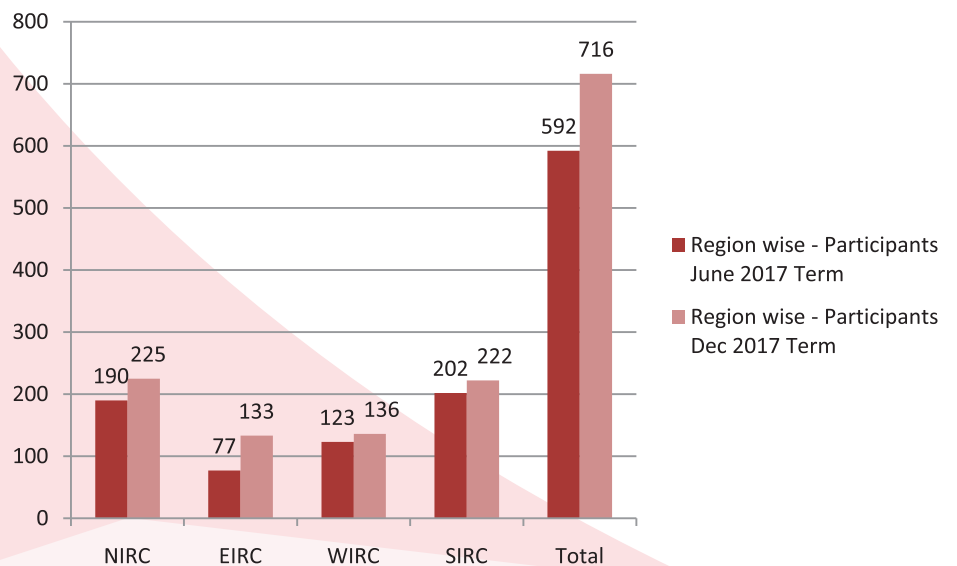
