### I. COMPANY PROFILE

MOIL Limited is a Schedule "A" Miniratna Category-I Company. It was originally incorporated as Manganese ore (India) Limited in the year 1962.

MOIL is a manganese ore mining company located in the states of Maharashtra and Madhya Pradesh. It has 10 mines, 7 of which are underground. It is the largest manganese ore producer in India.

It also has a EMD Plant for manufacture of 1000 MT per annum capacity of Electrolytic Manganese Dioxide (EMD) the product of which is used for the manufacture of dry battery cells. It also has a Ferro Manganese Plant.

MOIL is listed on National Stock Exchange and Bombay Stock Exchange. The shareholding in the company, of Govt. of India, Govt. of Maharashtra and Govt. of Madhya Pradesh is 71.57%, 4.62% and 3.81% respectively. Rest 20% shares are held by the public.

The authorized and paid up capital of the Company was Rs.250 crores and Rs.168 crores respectively as on 31.03.2016.

#### **II. JOB DESCRIPTION AND RESPONSIBILITIES**

Director (Finance) is a member of Board of Directors and reports to Chairman and Managing Director. He is in overall charge of finance and accounts functions of the organization, and is responsible for evolving and formulating related policies and their implementation.

#### III. ELIGIBILITY

#### 2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and **not** in a contractual/ad-hoc capacity – in one of the followings:-

- (a) Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);
- (b) Central Government including the Armed Forces of the Union and All India Services;
- (c) State Public Sector Enterprise (SPSE) where the annual turnover is \*Rs 2000 crore or more;
- (d) Private Sector in company where the annual turnover is \*Rs 2000 crore or more.
- (\* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)

#### 3. QUALIFICATION:

The applicant should be a Cost Accountant/Chartered Accountant/MBA with good academic record from a recognized University/Institution.

#### 4. EXPERIENCE:

The applicant should have at least five years of cumulative experience during the last ten years at a senior level in corporate financial management and accounts in a large organization of repute.

#### 5. PAY SCALE/ RANK/ LEVEL:

The minimum length of service required in the eligible scale/rank/level will be one year for internal candidates, and two years for others as on the date of vacancy.

#### 6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

#### IV. DURATION OF APPOINTMENT

The appointment shall be for a period of five years from the date of joining or upto the date of superannaution or until further orders, whichever is earlier.

- (f) Private Sector: directly to the PESB.

- (b) Whether the company is listed or not; if yes, the documentary proof (please provide URL or attach/enclose);

- (d) Self-attested copies of documents in support of age and qualifications;

#### VI. UNDERTAKING BY THE APPLICANT

An applicant has to give an undertaking as a part of the application that he/she will join the post, if selected. If an applicant does not give such undertaking, the application would be rejected.

### 2. For candidates from CPSE

- (a) If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.
- (b) Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

#### 3. For candidates from SPSE/Private Sector

- (a) If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- (b) Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
- **4.** In the above cases, no request for relaxation or otherwise would be entertained.
