Frequently Asked Questions (FAQs)

61st National Cost and Management Accountants' Convention – 2024

27 - 30 June, 2024, Tent City 2, Ekta Nagar, Statue of Unity, Gujarat

Q.1 What is the mode of delegate registration for 61st National Cost and Management Accountants' Convention (NCMAC), 2024?

Ans. The delegate registration for NCMAC-2024 can be done in online mode only.

Please upload your Adhaar details.

Please choose options for reaching at the venue, either by Bus or Self. In case chosen Self, please provide vehicle no. and other details to avoid any inconvenience for entry at the venue.

For Registration, Govt. approved Identity Card viz. Aadhaar/ Valid Driving Licence/ Voter ID is a must.

Q.2 What would be the different mode of online payment for delegate fee in NCMAC?

Ans. Delegate fee is to be paid in online mode only.

The Online payment options are available through Debit Card, Credit Card and UPI platform.

Q.3 How to register and pay delegate fee for twin/triple sharing basis?

Ans. In case of payment of registration and delegate fee for twin/triple sharing basis, all the delegates have to register and pay delegate fee separately.

Q.4 How to intimate in case a delegate has registered and paid in twin/triple sharing basis category and wish to stay together in the same Tent?

Ans. The delegate should send intimation for sharing the tent on twin/triple sharing basis by sending a mail at ncmac2024@icmai.in latest by **23rd June 2024**.

Q.5 How to register accompanying spouse?

Ans. The delegate should choose an option to add accompanying spouse. 'Spouse' means married husband or wife.

Q.6 How to register accompanying children?

Ans. The delegate should choose an option to add accompanying children (above 6 years) of a parent delegate.

Q.7 What is included in delegate fee?

Ans. Delegate fee includes accommodation at Tent City 2, food and delegate kit only.

Delegate fee shall not cover cost of travelling to and from, local transportation, visit to Statue of Unity, any other incidental expenses including sightseeing. All additional charges shall be borne by the delegates.

Q.8 Whether a delegate can register on the spot at the Venue of the Convention?

Ans. No spot registration is allowed. A delegate must register and pay in advance latest by **23rd June 2024**.

Q.9 Whether accompanying spouse and children are eligible for delegate kit?

Ans. The accompanying spouse and children (above 6 years) would not be eligible for delegate kit.

Q.10 Whether delegate fee is refundable?

Ans. No. The entire fee is payable in advance and is not refundable.

Q.11 Whether a delegate can stay in a place other than the venue?

Ans. The stay inside the Tent City 2 is mandatory for the delegates.

Q.12 Whether any early check-in is possible at venue?

Ans. Check in on **27th June 2024 from 1pm** onwards.

Q.13 Whether any transport facility is available for the delegates from Ahmedabad, Vadodra, Surat?

Ans. It is optional to avail Bus Transport (AC) facility from Ahmedabad, Vadodara, Surat. The bus facility will be available at the designated time to and from to Tent City 2, Ekta Nagar.

If opted for bus transport facility, a delegate must pay for that in advance along with the delegate fee.

The transport details will be informed by e-mail to the delegates who have paid for the bus facility.

Q.14 How many CPE Hours will be awarded for attending the NCMAC-2024?

Ans. The members of the Institute of Cost Accountants of India will be awarded **10 CPE hours** for attending NCMAC-2024 from 27th June 2024 to 30th June 2024.
