1. The Diploma Examination comprises three papers of 100 marks each.

The participants who will score 50 percent or more in the examinations for each module will be declared successful.

2. Each candidate has to submit the project report on or before 30th July, 2016.

3. Examination details:

(i) Examination Fee for diploma examinations is Rs, 1200/- (Rupees Twelve hundred only) for all the papers OR for a single paper.

(ii) Examination fees to be paid through Demand Draft of requisite amount drawn in favour of  
"the Institute of Cost Accountants of India" Payable at Kolkata

(iii) The Diploma examinations will be held in the month of June/December. The last date for submission of application form is sep 30<sup>th</sup> without late fee and 10th October with late fee for December term and 31<sup>st</sup> March without late fee and 10<sup>th</sup> April with late fee for the June Term

(iv) The examination is conducted at the following centers: Please refer Annexure-1

4. Only one Application for must be filled up given the choice of papers. Multiple Applications by the same candidate are liable to be rejected.
