The participants who will score 50 percent or more in the examination will be declared successful.

2. Examination details:

- (i) Examination Fee for diploma examinations is Rs, 1200/- (Rupees Twelve hundred only) for all the papers OR for a single paper.
- (ii) Examination fees to be paid through Demand Draft of requisite amount drawn in favour of "the Institute of Cost Accountants of India" Payble at Kolkata
- (iii) The Diploma examinations will be held in the month of June/December. The last date for submission of application form is Sep 30th without late fee and 10th October with late fee for December term and 31st March without late fee and 10th April with late fee for the June Term
- (iV) The examination is conducted at the following centers: Please refer Annexure-1
- 3. Only one Application for must be filled up given the choice of papers. Multiple Applications by the same candidate are liable to be rejected.
- 4. A candidate must write in Block Letters the name of his/her Examination Centre and the Examination Centre Code in the space provided for in the Application Form. Centre once opted for will not be changed under any circumstances. See annexure for the Examination Centre and corresponding codes.
- 5. A Candidate must send his/her application form and remittance in respect of his/her own candidature only.
- 6. Incomplete applications forms are liable to be rejected.
- 7. Request for change of Centre or Paper will not be entertained under any circumstances.
