- ❖ The selected firms will be paid ₹:10,000.00 (Plus Applicable Taxes) per month per branch for conducting concurrent audit as a remuneration and ₹:1,000.00 per month per branch out of pocket expenses (with applicable taxes). Concurrent audit may also include audit relating to prior period for which a lump sum amount may be paid as decided by the bank's management and such amount may be lesser than the aforesaid amount.
- CA / CMA Firms are not entitled for any additional benefits or perquisites.
- ❖ An audit firm may be allocated upto a maximum of 3 branches (or offices) for a maximum period of 12 months that may be extended further subject to satisfactory performance.
- Other terms & conditions of empanelment will be informed at the time of assignment of audit / execution of agreement & documents.
