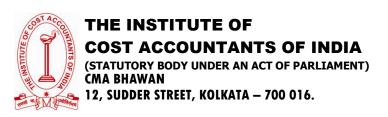

Finance Minister Nirmala Sitharaman on Friday interacted with the representatives of 14 distinguished US universities and invited them to set up foreign universities/institutions at the International Financial Services Centre (IFSC) in Gandhinagar, Gujarat. - Commercial paper rates have surged by about 15-20 basis points in about ten days, reducing the amount of funds banks park with the central bank and increasing working capital loans from commercial banks. - ICICI Bank reported a 59.4% jump in its standalone net profit to Rs 7,018.71 crore in the fourth quarter of fiscal 2021-22, led by a sharp growth in net interest income and lower provisions. This is its highest ever quarterly net profit. The lender had a net profit of Rs 4,402.61 crore in the fourth quarter of 2020-21.

The ED said this in its second supplementary (third overall) charge sheet filed in special court here recently against Rana Kapoor, his family, Wadhawans and others in a money laundering case.
