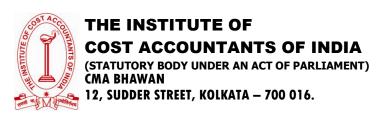

- The surplus that the RBI transferred to the Government in the last fiscal year fell sharply mainly due to a jump in expenditure, which was led by interest payments to banks on their excess funds parked with it, the bank's annual report showed. - The Mumbai bench of the NCLT has admitted a plea of Yes Bank to initiate bankruptcy proceedings against real estate developer Radius Infra Holdings for the failure of group firms to repay about ₹700 Cr of term loans advanced by the private lender. Bhrugesh Amin has been named the Interim Resolution Professional (IRP) of the Co by the tribunal.

- The SEBI carried out 'search and seizure' at 16 entities including offices of Axis Mutual Fund, stock brokers and individuals as part of the ongoing probe into suspected wrongdoings by two former fund managers of Axis MF, said people with direct knowledge of the matter. The capital markets regulator's searches for evidence were done at 30 locations across various cities and towns in Maharashtra and Gujarat, the person said.

- Many insurance firms and a few banks have hired forensic investigators to look into their systems' weaknesses
 on concerns that their treasury staff may have engaged in front running or insider trading, similar to what
 happened at Axis Mutual Fund. Most of the major private insurance companies have started investigations to
 check the prospect of any employee exploiting their systems, people aware of the development said.
