- ❖ The selected firms will be paid remuneration of ₹:10,000.00 (Plus applicable Taxes) per month per branch for conducting Concurrent Audit and ₹:1,000.00 per month per branch out of pocket expenses (and applying applicable taxes.)
- ❖ **CA / CMA Firms** are not entitled for any additional benefits or perquisites.
- ❖ Each Audit Firm may be entrusted with maximum 3 branches to conduct monthly concurrent audit / Revenue Audit for a period of 12 months, which may be extended further subject to satisfactory performance and request letter from **CA / CMA Firm** that they are interested to serve further. A quarterly performance review of the firms are done by the Bank.
- ❖ **Other terms & conditions of empanelment will be informed at the time of assignment of Audit.**



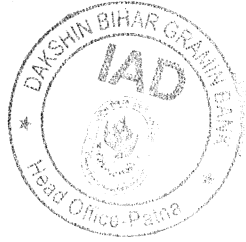
