I request the members of the profession, experts and industry representatives to give their views / comments / suggestions on the proposed exposure draft within stipulated date of **8**th **November 2010**. The exposure draft is available on the website of the Institute.

The members are requested to give their **specific views** on <u>paragraph 4.12</u> <u>of the ED CAS</u>, particularly on the exclusion of following points from the <u>definition of Overheads</u>:

- Donation and gifts including political donations;
- Contribution for Corporate Social Responsibility (CSR) activities;
- Bad Debts;
