Elections to the Council & Regional Councils – 2023

Sub.: LIST OF VOTERS OF SOUTHERN INDIA REGIONAL CONSTITUENCY

In pursuance of sub-rule 6 of Rule 6 of the Cost and Works Accountants (Election to the Council) Rules, 2006 as amended, further to the List of Voters for the Elections to the Council & Regional Councils, 2023 published vide Notification No. EL-2023/16 dated 31st March, 2023, the following additions/corrections have been made on the basis of information/particulars subsequently made available :

- A. The voters under Serial Numbers 4339, 4340, 4341, 4342, 4344, 4345, 4347, 4348, 4349, 4350, 4351, 4352, 4353, 4354 and 4355 allotted under the town heading 'ELURU (DT. WEST GODAVARI, A.P.)' at page numbers 265 and 266 of the List of Voters, 2023 of Southern India Regional Constituency are permitted to vote by post instead of vote by poll. Accordingly, Booth No. B-49 stands dissolved.
- B. The voters under Serial Numbers 4328, 4331 and 4334 allotted under the town heading 'EAST GODAVARI' at page numbers 265 and 266 of the List of Voters, 2023 of Southern India Regional Constituency are permitted to vote by post instead of vote by poll.
- C. The voters under Serial Numbers 6180, 6181, 6182, 6183, 6184, 6185, 6186, 6187, 6188, 6189, 6190, 6191, 6192, 6193 and 6194 allotted under the town heading 'KAKINADA (A.P.)' at page numbers 378 and 379 of the List of Voters, 2023 of Southern India Regional Constituency are permitted to vote by post instead of vote by poll. Accordingly, Booth No. B-58 stands dissolved.
- D. The voters under Serial Numbers 7017, 7018, 7021, 7023, 7024, 7027, 7033, 7036, 7039, 7040, 7042, 7044, 7047, 7049, 7050 and 7053 allotted under the town heading 'ONGOLE' at page numbers 427, 428 and 429 of the List of Voters, 2023 of Southern India Regional Constituency are permitted to vote by post instead of vote by poll. Accordingly, Booth No. B-73 stands dissolved.
- E. Since the number of Voters fall short of 15 in the Polling Booth No. B-66 at KURNOOL (A.P.) of the List of Voters, 2023 of Southern India Regional Constituency, the voters under Serial Nos. 6513, 6514, 6517, 6518, 6520, 6522, 6523, 6524, 6525, 6527, 6528, 6530, 6531 and 6533 at page numbers 397 and 398 have been permitted to vote by post instead of voting at Polling Booth No. B-66, which stands dissolved.
