- 4. Revenue and Capital Budget in the format backed by the extract of Resolution

Visibility is one of the important criteria for growth of any organization so; you are requested to conduct the Career Counseling Programs at different Schools and Colleges. For the same, kindly go through the format and other documents sent by the Secretariat and send your proposal, so that along with monetary support, standardized materials also could be provided to you.

Another way of increasing visibility is by releasing the quarterly News Bulletin which would cover various activities, topics of professional/stakeholders interest, pictures of CMA Alumnus, and overall details with respect to the profession and circulate the same amongst Public Schools, Colleges, Govt. departments, Industries, PSUs etc.

- You may plan ways to access educational Institutions in the untapped sub urban areas
 of your jurisdiction to create awareness of the profession.
- Conduct more programs on Professional interest and invite stakeholders and the Govt.
 departments to get their support with regards to employment opportunities alongside
 increasing the scope for practitioners.
- In case of any Press meet organized at Chapters level or publications in connection to the profession may be intimated to IT department for hoisting the same in Institute's Website.
- You may also share the write up along with photographs of events immediately after program is over to the Journal department for publication in monthly newsletter 'The Management Accountant.'

The suggestions received during Regional Council & Chapter Meets and National Regional Council and Chapters Meet held at Munnar, Kerala have been recorded and shall be circulated to the concerned Committee/ Directorate to resolve the issues and consider the implementable suggestions. The training of employees of Chapters and Regional Councils will be conducted very soon.
