As you are aware, the MCA has amended Schedule III to the Companies Act 2013 on 24 March 2021 with an objective to increase transparency and provide additional disclosures to the users of the financial statements. These amendments were made effective from 1st April, 2021, therefore, applicable to the Financial Statements prepared for the F.Y. 2021-22 and onwards. Some of the amendments in Schedule III are in line with the amendments prescribed in CARO 2020. These amendments propelled the makers of the financial statements to provide additional disclosures which were earlier never made and compiled.
