# Global effect: LPG rate cut by Rs 113, jet fuel prices by 4.1%

Price of non-subsidized cooking gas (LPG) was cut by a steep Rs 113 per cylinder and that of jet fuel (ATF) by 4.1 per cent as international oil rates slumped to multi-year lows. A 14.2-kg cylinder of non-subsidized LPG will now cost Rs 752, down from Rs 865 previously, in Delhi, oil companies announced. This is the fifth straight reduction in rates of non-subsidized or market priced LPG, which the customers buy after exhausting their quota of 12 cylinders at subsidized rates, since August.

# India to set up pipeline link to Bangladesh

India and Bangladesh are looking at a comprehensive partnership in the energy sector even as the neighbour is keen on joining the Turkmenistan-Afghanistan-Pakistan-India natural gas pipeline. Also, Indian refineries are looking at possibilities of selling petroleum products to the South Asian neighbour through a pipeline.

"With the signing of the SAARC (South Asian Cooperation) Association Regional framework for energy cooperation, it has become a reality. Besides, export from Turkmenistan is attractive," said Tawfiq-e-Elahi, advisor to Prime energy and Minister, mineral resources, Bangladesh. To begin with, diesel is likely to be transported through the pipeline. "A feasibility study for the pipeline is currently underway," a senior petroleum ministry official said. The pipeline is estimated to cost Rs 200 crore and would have a capacity of one million tonne. It could also be further extended into Myanmar. India already sells petroleum products in Nepal, Bangladesh and Mauritius.

#### Core sector output accelerates to 6.3% in October

Growth in eight key infrastructure sectors reached an impressive four-month high of 6.3 per cent in October compared to 1.9 per cent the previous month but analysts said expansion in industrial production was still likely to be mild. The October growth was mainly due to a surge in coal production, electricity generation and refinery products. The eight (core) sectors output rose 4.3 per cent in the first seven months of this financial year, slightly higher from 4.2 per cent in the same months of last year.

During the month, coal production grew 16.2 per cent, closely followed by electricity generation that rose by 13.2 per cent. Production of petroleum refinery products grew by 4.2 per cent compared to the corresponding month of 2013-14, according to data issued on 1<sup>st</sup> December by the ministry of commerce and industry.

#### Plastic processors gear up for life after HPL

Petrochemicals (HPL) has severely affected companies in the allied sector such as plastics processors.HPL, one of the largest manufacturers of high-density polyethylene in the country, supplies different grades of polymers mainly in the eastern India region. The long closure of HPL has disrupted the supply of polymers to plastics processors, especially the makers of the injection-moulded products such as syringes, crates, buckets, filaments, etc. As a result, many of such units had to close down. The HPL shutdown led to the closure of nearly 150 such units, rendering thousands jobless, said Ramesh Kumar Rateria, vice-president of Indian Plastics Federation. However, due to a prolonged shutdown, the units have decided to import polymer.

### SBI cuts deposit rates by 0.25 per cent

## RBI working on consumer rights charter

The RBI is working towards bringing out a charter on consumer rights, said Umashankar Paliwal, Executive Director of the apex bank. Addressing a conference on Consumer Product Safety, he pointed out that a draft charter comprising five rights - to fair treatment, transparency, honest dealing, suitability, privacy, grievance redress and compensation - to deal with RBI-regulated entities has been put up for public comments. He also appealed to consumers to exercise caution and avoid falling prey to online lottery scams that ask people to pay 'service charges' to transfer large sums of money to their bank accounts, and other Ponzi schemes.

Soon, PSU bank ATMs will be able to print in Hindi

ATMs installed by state-owned banks will soon have the facility for issuing the transaction in Hindi. finance minister Arun receipt Jaitley said on Friday in response to a question in "The the Lok Sabha. government has instructed public sector banks (PSBs) to install those ATM machines which can produce receipts in both Hindi and English languages. PSBs have been advised to ensure that all ATM machines have facility of doing transactions/printing in Hindi as well as in English. However, no time frame has been prescribed for installation of such ATM machines," the written statement said. Most ATMs have a bilingual option on their home screens. Some machines, like those installed by ICICI Bank, offer a regional language option as well in non-Hindi speaking states.

### **○** White Label ATMs (WLAs) in India – Guidelines

To allow WLAs to accept international credit/debit/prepaid cards. The cards issued under card payment network schemes (authorized under the PSS Act 2007) will be allowed for the purpose. The WLA operators (WLAO) have to ensure that they have established technical connectivity with the respective card network operators either directly or through their sponsor banks. However, in the case of cards issued under any other card scheme, the routing and settlement should take place based on the bilateral arrangement put in place by the existing authorized networks for such purpose.

In a review meeting of PMJDY held recently, all the banks have been advised to cover the gap including of their Regional Rural Banks (RRBs) by December 15.

# No plan to impose tax on agricultural income: Jaitley

The Centre will not impose tax on agricultural income, Finance Minister Arun Jaitley has said. Jaitley's response in the Lok Sabha on Friday puts to rest questions on whether Government will endorse the Parthasarathi Shome led Tax Administration Reform Commission (TARC) recommendation for taxing of large farmers with income above Rs. 50 lakhs a year. The report was submitted on December 3. The measure, in conjunction with the reintroduction of fringe benefits tax and banking cash transaction tax, was suggested in order to widen the tax base. Shome had noted the move could block an escape route for black money but that such a move would need political consensus across party lines. That, in addition to a strong farm lobby, makes it unlikely for

recommendation to be considered in the 2015-16 Budget.

# **○** Spices export up 12% in Apr-Sep

Sustaining robust demand in international markets, Indian spices registered an export volume of 421,570 tonnes during April-September this year with their value pegged at Rs 6962.86 crore (USD 1152.08 million) as compared to 376,584 tonnes and Rs 6,364.64 crore (USD1073.85 million), respectively during the corresponding period a year earlier.

"Spices export has been in tune with the targets set up by the Commerce Ministry for the current fiscal. As compared to April-September 2013, the export registered a growth of 12% and 9% in terms of volume and value, respectively," said A Jayathilak, Chairman, Spices Board. Chili, mint products, cumin, spice oils & oleoresins, pepper, turmeric, coriander, curry powder/paste and fenugreek contributed substantially to spice export basket as the demand for Indian spices surged phenomenally at the global level. Chili continued to propel the growth story as India's largest exported spice, accounting for 161,000 tonnes in quantity and Rs 1,547.30 crore in value during April-September 2014.

# Govt. empowers CMAs / CAs nominated as special auditors, to conduct Service Tax Audits

Every assessee, shall, on demand make available to the officer empowered under sub-rule (1) or the audit party deputed by the Commissioner or the Comptroller and Auditor General of India, or a cost accountant or chartered accountant nominated under section 72A of the Finance Act. 1994:

- (i) the records maintained or prepared by him in terms of sub-rule (2) of rule 5;
- (ii) the cost audit reports, if any, under section 148 of the Companies Act, 2013 (18 of 2013); and
- (iii) the income-tax audit report, if any, under section 44AB of the Income-tax Act, 1961 (43 of 1961).

### States may get power to tinker with 'State **GST'** rates

The Centre may allow States to unilaterally tinker with State-level Goods and Services Tax (State GST) rates as part of its efforts to build a consensus on the proposed dual-GST system in the country. In the GST architecture proposed during the UPA regime, the Centre was to decide on the rates in consultation with States. The main issue was that all the States had to follow the

rates and there was no room to unilaterally deviate from them. They had to go to the GST Council to change the rates. India is looking to implement a dual-GST system, where the Centre will impose a Central GST (CGST) and the States will impose a State GST (SGST). Over 150 countries have implemented GST. The proposed flexibility for States to tinker with SGST rates could enable consensus on the GST implementation front, official sources said.
