- Providing all-inclusive service including all spares, etc. during defect liability period.
- All engineering, equipment, labour, and permits required to satisfactorily complete the work required by this Specification.
- Annual Maintenance Contract (AMC) charges to be mentioned that would be covered once the warranty period of 12 months is over.
- To provide the Solution to capture, store, and analyze digital video images to enable central monitoring, increase operational efficiency, reduce liability, minimize risk and secure people & property of the Institute.
- To provide CCTVs Surveillance System to be functional on 24x7 basis i.e. 24 hours all the days and need to have at least 30 days data storage capacity for all CCTVs.
- During the warranty period of 12 months (Defect Liability Period), the contractor (successful bidder) shall make
 periodical inspection of the working of the entire system free of charge at least once in 15 days or earlier, if

- The quoted values be calculated on 70:30 ratios wherein Total Cost of supplying the items is given the weightage of 70% and quoted AMC charges an weightage of 30%.
- The L1 value would be calculated as:
 - o [Total supply cost (A)] X 0.7 + [AMC value (B)] X 0.3) for Technically qualified bidders; however, payment will be made on actual consumption basis.
- If a firm quotes NIL charges/consideration, the bid shall be treated as unresponsive and will not be considered.
- Adequate precaution shall be taken to prevent danger from electrical equipment. No materials on any of the sites of work shall be so stacked or placed as to cause danger or inconvenience to any person.
- Although the details presented in this Tender Document consisting of conditions of contract, scope of work and technical specifications have been compiled with all reasonable care, it is the bidder's responsibility to ensure that the information provided is adequate and clearly understood.
- Bidders are requested to check for corrigendum/addendum (if any) at the Institute's website before finally submitting their bids.

Other Conditions:

- i) The price quoted by the bidder should remain valid for 30 days.
- ii) Canvassing in any form in connection with the contract is strictly prohibited.
- iii) Wherever the ground is dug for cable laying etc, it shall be restored to original condition. All debris etc. shall be disposed off to the nearest defined place by municipal authority or by Institute, as applicable.
- iv) The IP Based Video Surveillance system shall be a Hybrid System with distributed architecture having control station at the Institute's defined cabin (Control Station) viewing facility at that cabin.
- v) While lying cable, no wire should be hanged anywhere at the sites; all wire should be concealed in PVC pipe; no extra cost will be paid for this job.
- vi) A junction box (iron make) must be set up for each network switches and power board from where cables will be distributed at required places; no extra cost will be paid for this job.
- vii) After commissioning the Video surveillance system, the same shall be demonstrated for all its capabilities to the relevant user department to make them familiar with the system on mutually agreed dates.
- viii) The quantities mentioned for procurement is only estimated, actual consumption may vary and therefore payment will be made on actual consumption basis only.
- ix) Training: Upon completion of the installation & commissioning the Successful Bidder shall provide the hands-on training on the installed equipment to the concerned officials along with the training materials on the equipment installed at Institute.
- x) Once the supply order is placed, it will be the vendors' responsibility to make the project functional. Any additional cost incurred for completing the project and for which the vendor has not bid at the time of submission of the final offer will be borne by the vendor.
- xi) Institute reserves the right to extend the last date for receipt of bids at its own discretion.
- xii) The Institute may, for any reason whether at its own initiative or in response to the clarification requested by the prospective bidder, issue amendment in the form of addendum during the bidding period and subsequent to receiving the bids. Any addendum thus issued shall become part of bidding document and bidder shall submit the addendum duly signed and stamped in token of his acceptance.
- xiii) Institute reserves the right to modify the quantity included in the schedule of requirements at any time after acceptance of tender without a notice. The bidders shall have no claim to any payment of compensation.
- xiv) Institute reserves the right to repudiate the contract and entrust the work to any other third party in the event of breach of terms and conditions of this agreement or in the event of unsatisfactory performance observed by the Institute.
- xv) Institute may ask clarifications if any during the evaluation and the bidders are expected to respond. Lack of response from them will enable the Institute arrive at its own decision about such bids.

- xvi) The Institute shall not be responsible for any loss, damage, theft, of any item in course of transit and for any financial loss or other injury to any person deployed by the contracting firm in the course of their performing the duties to the Institute in connection with this Tender.
- xvii) The work executed by the vendor should be to the satisfaction of the concerned officer where work was executed. If the same is not found satisfactory, the firm will have to do the job again at its own cost. The decision of the concerned officer and of the Institute in this regard will be final and unassailable and binding on the vendor.
- xviii) Any damage is caused to any equipment/or items available at the office premises due to negligence of the contractor's work force shall be entirely on contractor, the amount so involved on this account shall be deducted from the payment due to contractor.
- xix) The vendor shall have to make his own arrangements for storage of materials required for execution of the work and Institute in any manner shall not be held responsible for the storage and safe custody of the said materials at work site.
- xx) The order will be placed for the best interest of the Institute

Warranty and Annual Maintenance

- The entire equipment/ system shall be warrantied to be free from defective workmanship or materials and any defects that may appear within 12 months (one year) from the date of issue of completion certificate for the work, which in the opinion of the Institute have arisen from bad workmanship or materials, shall upon intimation by the Institute, be made good by the Contractor at his own cost within the time specified.
- During the said period of 12 months (Defect Liability Period), the contractor (successful bidder) shall make periodical inspection of the working of the entire system free of charge at least once in 15 days or earlier, if required, and attend to such other service that may be required of him. The warranty period shall be 12 months from the date of handing over of the entire system to the Institute.
- During Defect Liability period the contractor (successful bidder) shall provide on-site comprehensive maintenance, which includes preventive as well as corrective maintenance. The firm awarded with the maintenance contract shall carry out preventive maintenance of equipment on quarterly basis/ as per requirement and shall maintain the proper record thereof.
- Defect Liability Period shall cover each part of CCTV camera and accessories including plastic body and parts, replacement of any part necessary for keeping the CCTV system active and free from any defects/disturbance, any unscheduled call for corrective and/or preventive maintenance services, taking appropriate measures/steps in time to set right the malfunctioning of the CCTV of the system. Maintenance of the CCTV surveillance system includes Camera Visibility Test, NVR Recording, NVR Recording Test, NVR Settings Verification, and Disk Error Check. Replacement of CCTV Parts.
- Once the warranty period is over, the selected party would be continuing with the annual maintenance contract (AMC) for another year till completion of successive five years. All the above mentioned conditions would be applicable for the AMC as well.
- Availing the AMC on expiry of warranty period (60 months) would be at the discretion of the Institute
