<u>2. Scope of work :</u>

3. Eligibility :

- 3.1 Bidder must be a profit making organization in the previous three financial years with an annual turnover of at least Rs.50 Lacs. per year is preferable for last three financial years. Audited bank statement of 2016-17, 2017-18 and 2018-19 to be enclosed.
- 3.2 The vendor shall be Original Equipment Manufacturer (OEM) of desktop computers and peripherals or the Authorized System Integrator/ Partners / Dealer of OEM

OR

The bidder shall have appropriate support relationship with OEM Channel/Service partner etc. and must submit OEM authorization documents. Proof of document that the bidder is authorized OEM Partner to be enclosed.

- 3.3 The bidder should have executed at least three similar work order of same or higher value during the last three years. Copies of work order to be enclosed.
- 3.4 Bidders shall have PAN, TAN, GST registration

- 3.5 Must hold ISO 9000 2000 certification, Copy to be attached
- 3.6 Copies of valid trade licenses, permissions to be enclosed.
- 3.7 Should have undertaken such activities of at least 2 State/Central Universities, Govt. education boards, Govt. examining commissions. Copies of at least 3 such work orders pertaining to immediate 3 years need to be enclosed.

<u>4. Instructions for bidders :</u>

- 4.1 The rates to be offered should include all designing, typesetting, printing, packing, labour, transportation, loading, unloading, supply, etc. No other additional payments would be made.
- 4.2 Taxes as applicable will be paid extra.
- 4.3 Any arithmetical error i.e. discrepancy between unit price and in total, error in total corresponding to the addition or subtraction of subtotals, discrepancy between words and figures shall be corrected by examining committee.
- 4.4 Bidders shall bear all costs associated with the preparation and submission of its bid.
- 4.5 Adequate precaution shall be taken to prevent danger from electrical equipment. No materials on any of the sites of work shall be so stacked or placed as to cause danger or inconvenience to any person.

5. Terms & Conditions :

- 5.1 Schedule of delivery
 - a. Time Within 15 days from acceptance of order.

- 5.2 The bidder/s should adhere with all seriousness to the time schedule provided by the Institute.
- 5.3 Financial bids of only those bidders will be opened who have qualified in the technical bid analysis.
- 5.4 The price quoted by the bidder should remain valid for 90 days.
- 5.5 Period of Contract "ONE TIME" will end automatically on satisfactory supply of the items.
- 5.6 If a firm quotes NIL charges/consideration/abnormal charges, the bid shall be treated as unresponsive and will not be considered.
- 5.7 Canvassing in any form in connection with the contract is strictly prohibited.
- 5.8 L1 will be decided based on the consolidated amount quoted in the darkened boxes of Total Rs.
- 5.9 Institute reserves the right to extend the last date for receipt of bids at its own discretion.
- 5.10 Once the supply order is placed, it will be the vendors' responsibility to make the project functional. Any additional cost incurred for completing the project and for which the vendor has not bid at the time of submission of the final offer will be borne by the vendor.
- 5.11 Wherever the ground is dug for cable laying etc, it shall be restored to original condition. All debris etc. shall be disposed off to the nearest defined place by municipal authority or by Institute, as applicable.



- 5.12 The Bidder shall not sub-contract the mentioned work to any organization, person, firm or its franchise without the prior approval of the Institute
- 5.13 The Institute may, for any reason whether at its own initiative or in response to the clarification requested by the prospective bidder, issue amendment in the form of addendum during the bidding period and subsequent to receiving the bids. Any addendum thus issued shall become part of bidding document and bidder shall submit the addendum duly signed and stamped in token of his acceptance.
- 5.14 Institute reserves the right to modify the quantity included in the schedule of requirements at any time after acceptance of tender without a notice. The bidders shall have no claim to any payment of compensation.
- 5.15 Institute reserves the right to repudiate the contract and entrust the work to any other third party in the event of breach of terms and conditions of this agreement or in the event of unsatisfactory performance observed by the Institute.
- 5.16 Institute may ask clarifications if any during the evaluation and the bidders are expected to respond. Lack of response from them will enable the Institute arrive at its own decision about such bids.
- 5.17 The Institute shall not be liable for any loss, damage, theft, burglary or robbery of any personal belongings, equipment or vehicles of the engaged personnel of the contracting Firm.
- 5.18 The work executed by the vendor should be to the satisfaction of the concerned officer where work was executed. If the same is not found satisfactory, the firm will have to do the job again at its own cost. The decision of the concerned officer and of the Institute in this regard will be final and unassailable and binding on the vendor.
- 5.19 Upon being selected as the successful bidder and being awarded the Order, the bidder is expected to reply to all queries/ complaints that may be raised by the Institute from time to time.
- 5.20 The participating bidder has to submit this tender document signed and sealed on each page, together with Technical Bid, as acceptance of the terms and conditions mentioned herein.
- 5.21 The order will be placed for the best interest of the Institute.

6. Warranty and Maintenance

- **6.1** The entire equipment/ system shall be warrantied to be free from defective workmanship, software or materials and any defects that may appear within 36 months (three years) from the date of issue of work completion certificate, which in the opinion of the Institute have arisen from bad workmanship or materials, shall upon intimation by the Institute, be made good by the bidder at his own cost within the time specified.
- **6.2** During the said period of 36 months (DLP Defective Liability Period), the contractor (successful bidder) shall make inspection of the entire system free of charge as and when require, and attend to such other service that may be required of him.
- **6.3** During Defect Liability period the contractor (successful bidder) shall provide on-site comprehensive maintenance, which includes preventive as well as corrective maintenance. The firm awarded with the maintenance contract shall carry out preventive maintenance of equipment on quarterly basis/ as per requirement and shall maintain the proper record thereof.
- **6.4** Defect Liability Period shall cover each part of Desktop computers and accessories including plastic body and parts, replacement of any part necessary for keeping the system active and free from any defects/disturbance, any unscheduled call for corrective and/or preventive maintenance services, taking appropriate measures/steps in time to set right the malfunctioning of the system.
