L1 for 20 Mbps (1:1) Internet Leased Line will be decided based on price quoted in the Financial Bid Format of "Annexure III", similarly for other items the L1 will be decided based on "Annexure II" prices. For procurement, both these items are independent of nature, and both have no connection with each other.
- 5. The quotation must be valid for 30 days from the last date of quotation.
- 6. The Work Order will be communicated to the successful bidder by email.
- 7. Taxes shall be paid as applicable and quoted by the vendor.
- 8. Payment will be made after successful supply and installation of items and on submission of the invoice.
- 9. The statutory tax deductions on the payment made by the Institute would be done as per the prevalent Tax laws of Government of India.
- 10. The bidder should sign each page of this document and attach it with the bid document.
- 11. The committee reserves the right to reject any / all quotations without assigning any reason there for.
- 12. Conditional / Incomplete bids shall be rejected.
- 13. The bid should strictly be in the format specified in the tender document.
