- 6. In case of discrepancy between words and figures the amount in words would be considered.

Eligibility Conditions for the Bidder

The Eligible bidder should satisfy the below mentioned criteria and should submit valid Documentary evidence for the below mentioned points:

- 1. The bidder should be a company registered under the Companies Act, 2013 /Partnership Firm/Proprietorship entity and should have been in the similar kind business for more than 3 years.
- 2. The bidder should have an average turnover of INR 1 crore or above during audited financial year of 2022-2023 & 2023-24 and submit the following:
