- 1. Be registered under Companies Act / LLP Act / Partnership Act / Proprietorship.
- 2. Hold valid GST Registration and PAN.
- 3. Have experience of providing manpower to Government/PSU/Statutory Bodies/Educational Institutions.
- 4. Not be blacklisted by any Government/PSU organization (Self-declaration required)
