panel. Install suitable cable trays, conduits, and supports. Conduct testing and commissioning of the wiring to ensure safety and proper functionality.

- 4. **Excavation and Trenching for Underground Cables**Excavate and trench the area for laying underground cables according to the specified route plan. Lay the cables and backfill the trenches as required. Provide protective covers and markers to ensure safety and proper identification.
- 5. Coordination and Installation of Poles and Security Transformer Cubical

Coordinate with government authorities for the installation of poles and the security transformer cubical on the designated pole. Install and test the disc insulator, GI pin insulator, visual conductor, top and dropper channel angle, clamping with nuts and bolts, CTPT unit, and meter cubical. Ensure compliance with local regulatory standards.

- 6. **Documentation and Coordination for NOC Approval**Prepare and submit all required documentation to the safety department to obtain the NOC. Address any queries and comply with recommendations, if applicable. Coordinate with safety inspectors for site verification.

- 8. **Final Inspection and System Handover**Obtain final inspection and approval from the utility provider for the connection release. Commission the system and hand over the operational setup to the end-user. Submit as-built drawings and related documentation.
