ADVERTISEMENT FOR EMPANELMENT OF COST ACCOUNTANTS

Income Tax Department, Mumbai invites applications from reputed Cost Accountant Firms/Proprietary concerns for empanelment as Cost Accountants for FY 2024-25 and 2025-26, to carry out inventory valuation in accordance with the provisions of section 142(2A) of the Income-tax Act, 1961.

A. The minimum eligibility criteria for empanelment is laid down as under:

- 1. The applicant should be a reputed partnership firm or a proprietary concern or a Limited Liability Partnership (LLP) primarily engaged in the profession of cost accountancy and cost auditing, having a staff strength of at least 5, including a minimum of 2 Cost Accountants who have been working continuously with the applicant for at least last one year as on 31/03/2024. (Adequate evidences supporting the claim of staff strength and strength of Cost Accountant to be enclosed with the application and marked as Annexure A).
- 2. The applicant should have at least one office located in Mumbai Metropolitan Region. (Supporting evidence in the form of leave and license agreement, utility bills etc. should be enclosed with the application and marked as Annexure B.)
- 3. The applicant should have filed returns of income regularly upto AY 2023-24 and the Gross Professional Receipts of the applicant exclusively from professional services like cost consultancy/cost audits/internal audits/accountancy declared therein should not be less than Rs. 15 lakhs in any two out of the last five preceding financial years i.e from 2019-20 to 2023-24.
- 4. The applicant should have cost accountancy/cost auditing/internal audit/insolvency professional experience of minimum period of 5 years as on 31/03/2024. (Supporting

documents in the form of invoices raised etc. need to be enclosed with the application and to be marked as Annexure C.)

- 5. The applicant should have audited cost records of at least one business entity having turnover of Rs. 50 Cr or more in any two out of the last five preceding financial years i.e from 2019-20 to 2023-24. (Supporting documents including the details of entity audited need to be enclosed with the application and to marked as <u>Annexure D</u>.)
- 6. There should not be any proceedings related to income tax evasion/demand/penalty/ prosecution pending against the applicant or any of the partners of the applicant cost accountancy Firm/LLP/Proprietary concern on the date of application or should not have been held guilty with regard to tax evasion/penalty/prosecution under the provisions of I.T. Act, 1961.
- 7. The applicant should not have indulged/found indulged in any unethical professional practices; and also should not have been convicted and/or punished under any Central, State or other law.
- 8. The applicant should not have indulged in any professional misconduct nor should have faced any complaint u/s 21 of the Cost and Work Accountants Act, 1959 for irregularity in cost accountancy before the Institute of Cost Accountants of India.
- 9. The applicant with regard to the fulfilment of requirements stated at clause (6), (7) and (8) of minimum eligibility criteria, shall furnish an affidavit on non-judicial stamp paper of minimum value duly notarized by the notary public.

B. Terms & conditions:

- 1. Remuneration including expenses of and incidental to any special inventory valuation shall be decided on a case to case basis in accordance with Rule 14B of the I.T. Rules, 1962, and shall be paid by the Central Government/Income Tax Department.
- 2. The empanelment of Cost Accountants shall be made at the discretion of the Income Tax Department and the decision made shall be final. Apart from the above mentioned minimum eligibility criteria; the Income Tax Department reserves the right to consider other relevant factors/inputs/feedbacks etc. while finalizing the list of empanelment of Cost Accountants.
- 3. The applicant with regard to the fulfilment of requirements stated at clause (6), (7) and (8) of minimum eligibility criteria, shall furnish an affidavit on non-judicial stamp paper of minimum value duly notarized by the notary public.

C. The process of submission of application is as under:

1. Application (in physical form) in prescribed proforma completely filled with required information, along with annexures, affidavit and check list duly signed by the proprietor in the case of sole proprietary concern or by all the partners in case of a firm/LLP along with their seal and membership number at require places should be submitted to Room No 373 3rd Floor, Aayakar Bhavan, M.K. Road, Mumbai on or before 14.06.2024 either through post or in person.

2. Last date of submission application is 14.06.2024

D. The notice along with application form is available on official website of Income Tax Department, Mumbai www.incometaxmumbai.gov.in. Incomplete applications and applications received after the due date shall be summarily rejected and no correspondence in this regard will be entertained.
