About the Essay Competition

The ICMAI Registered Valuers Organization is conducting a National Level Essay Competition 2021-22 as a part of the celebration of Azadi ka Amrit Mahotsav.

Topic

Importance of Valuation - Building Aatm Nirbhar Bharat

Eligibility

The applicant must be a students, Academician or Professionals - CMA, CS, CA, CFA, MBA, LLB, B.Tech, B.E, B.Arch, Registered Valuers, Insolvency Professionals aged 18 years and above as on October 1, 2021, Wards and relatives of employees of ICMAI Registered Valuers Organization are not eligible to participate in this competition.

Guidelines for the Essay Submission

The Essay Competition entries shall be submitted in word and PDF format by the deadline.

Length of Essay

Not more than 3000 words including footnotes. There is no minimum word limit; however, participants are encouraged to submit essays of not less than 1500 words.

Format of the Essay

- Typed on A4 size.
- Font size shall be 12 points (English) in Times New Roman
- The space between the two lines should be 1.5
- Margins of one inch (2.54 cm) on all the four sides

Citations:

Participants may use any recognized style of referencing/footnoting system and this must be used consistently & uniformly throughout the Essay.

How to Submit?

- Participants can submit their essay through the google form vide google form link <u>https://docs.google.com/forms/d/e/1FAlpQLSd7eRiSMCH_CWZMS9tlq1bkxSjA-kmMHMcEYKUoRp_l20KQpg/viewform</u> By 31st December, 2021
- Written Essay in English language both in word & pdf format (NO SCAN).
- Candidates will nowhere mention their name or any identification in the text of essay.
- Entries submitted in hard copies and not in the prescribed format shall be summarily rejected without any intimation and NO query, correspondence; representation etc. pertaining to such entries shall be entertained by the Commission under any circumstances. Subject of such email must be 'ICMAI RVO Essay Competition 2021-2022".
- Entries shall be forwarded by the participant directly and shall not be forwarded through any other person at the mail prescribed above. All the fields in the entry form shall be compulsorily filled.
- Only original essays will be considered for the competition. Previously published essays shall be rejected out rightly. Any form of plagiarism will result in disqualification of the essay.

Awards

Winners will receive cash prizes as per the following table:
