

B.Com (F&CA) Course being offered by IGNOU

Course Brief:

- **Bachelor of Commerce with Major in Financial & Cost Accounting** (B.Com F&CA) exclusively for the CMA students.
- Students can simultaneously study B.Com (F&CA) along with CMA course. The course will enable students to improve their learning process by acquiring knowledge in new areas rather than concentrating in the same subjects, which are covered in the education scheme of the CMA Course
- This programme consists **Foundation and Intermediate courses** of the Institute and **Four papers** of IGNOU course. *Marks obtained by a student on passing the foundation course and Intermediate Course of the Institute will be credited in the Mark Sheet of B.Com (F&CA) along with marks obtained by the student on passing the 4-papers of IGNOU B.Com (F&CA) course as per Part-A below.*
- On completing Foundation and Intermediate courses of the Institute of Cost Accountants of India and 4 papers of IGNOU as per Part-A below, the students will be awarded Degree of B.Com (F&CA) by the IGNOU.

Eligibility for Admission:

- a) 10 + 2 or its equivalence; and
- b) Registration in CMA Foundation Course.

Note: Students who have passed CMA Intermediate Course shall also be eligible for admission.

To be eligible for the degree: B.Com (F&CA), a student has to complete courses as shown below:

Part A: Courses offered by IGNOU

- Compulsory

1. Foundation Course in Humanities and Social Sciences
2. Export Procedures and Documentation
3. Business Environment
4. Communication Skills in English OR English for Practical Purposes

Part B: Courses which are part of CMA Foundation Course

Students get “Automatic” credit transfer of marks of Foundation in the B.Com (F&CA)

1. Organization & Management Fundamentals
2. Accounting
3. Economics and Business Fundamentals
4. Business Mathematics & Statistics Fundamentals

Part C: Courses, which are part of CMA Intermediate Course

Students get “Automatic” credit transfer of marks obtained Intermediate to B.Com (F&CA)

1. Financial Accounting
2. Commercial and Industrial Laws and Auditing
3. Applied Direct Taxation
4. Cost & Management Accounting
5. Operation Management and Information Systems
6. Applied Indirect Taxation

Note: Papers studied in Syllabus 2012 by the Students are being mapped and credit for marks obtained in respective papers of Foundation and Intermediate courses as per Syllabus 2012 will transferred to B.Com (F&CA)
