1. Students should have valid Registration

If the registration has expired then application for De Novo Registration has to be made in the prescribed form available from any Chapter/Regional Council offices. The fees payable for such De Novo Registration is Rs.2000/- (DD to be drawn on "The I C W A of India" payable at KOLKATA.

2. Students should have valid Coaching Completion Certificate

If a student wishes to appear in the examinations under the Revised Syllabus, 2008 then the requisite coaching has to be completed as under:

If a student has not undergone coaching for any Stage(s) under Old Syllabus, then he will have to:

- a) Immediately approach the nearest Chapter/Regional Council to find out if they can accommodate him in any of the last batches of coaching to be held under Old Syllabus and complete the coaching under the Old Syllabus itself and then switch over to the Revised Syllabus, 2008.
- b) If step as mentioned in (a) above could not be fulfilled then the student has no other option but to enroll for fresh coaching under the Revised Syllabus, 2008 for the remaining group(s) as stated below:
