- 2. To fill the online examination form, students may visit the Institute's website www.icmai.in and pay examination fees Rs. 1000/- (for overseas candidates Rs. 7200/- (US \$ 80 X INR 90) through payment gateway by using Credit/Debit card.
- 3. CAT Course Part-I Examination will be conducted in **Multiple Choice Questions Mode through** offline OMR based from Centre.
- **4.** All candidates/students are encouraged to appear for the CAT Course Part-I Examination through the offline OMR-based format at designated centers.
- **5.** Each paper will consist of 100 Multiple Choice Questions, with each question carrying 1 mark, totaling 100 marks per paper. Each session will contain a total of 100 Multiple Choice Questions for 100 marks.
- 6. There will be no negative marking for wrong answers.
- 7. Standard of Pass-A Candidate of CAT Course Part- I shall be declared to have passed in the Examination if he/she secures minimum 40% marks in each paper and an aggregate of 50% of total marks.
- 8. <u>Last date of receipt of Examination Application forms is 7th October, 2024 (Monday).</u>
 There will be no extension in the last date of receipt of examination application forms for <u>December 2024 examination.</u>
- **9.** A candidate/student who is completing all conditions for appearing in the examination as per Regulations will only be allowed to appear for the examination.
