Frequently Asked Questions

Exemption to CAT Pass out Students for pursuing CMA Course under Syllabus 2022 as per CIRCULAR Ref No: G/128/02/2023 dated 13th February, 2023

S. No.	Frequently Asked Questions	Answer
1.	I have passed CAT COURSE PART —I under syllabus 2021 and enrolled in CMA Intermediate course under syllabus 2022. Am I eligible for exemption from appearing in Paper 5: Business Laws and Ethics (BLE), at the Intermediate Course under Syllabus 2022?	Yes, Students who have passed CAT Course under new syllabus 2021 and enrolled in CMA Intermediate course under syllabus 2022 are eligible for exemption.
2.	I have passed CAT course under old syllabus {Foundation Course (Entry Level) Part- I Examination} and enrolled in CMA Intermediate course under syllabus 2022. Am I eligible for the exemption ?	Yes, Students who have passed CAT Course under old syllabus {Foundation Course (Entry Level) Part- I Examination} and enrolled in CMA Intermediate course under syllabus 2022 are eligible for exemption.
3.	I have passed CAT COURSE PART —I under syllabus 2021 and enrolled in CMA Intermediate course under syllabus 2016. Am I eligible for the exemption ?	Students who have passed CAT Course PART –I under new syllabus 2021 and enrolled in CMA Intermediate course under syllabus 2016 are NOT eligible for exemption. Exemption is available under CMA Syllabus, 2022 only.
4.	I have passed CAT COURSE PART —I under syllabus 2021 and enrolled in CMA Intermediate course under syllabus 2016 but switched over to syllabus 2022. Am I eligible for the exemption ?	Yes, Students who have passed CAT Course PART –I under new syllabus 2021 and enrolled in CMA Intermediate course under syllabus 2016 but switched over to syllabus 2022 are eligible for exemption.
5.	What is the procedure to claim the exemption?	To claim the exemption, kindly visit Online Student Facility at the link https://eicmai.in/studentfacility/Login.as px?ReturnUrl=%2fstudentfacility%2f



6.	Is there any fee to claim the exemption?	To avail the exemption, a fee of Rs. One Thousand (1000/-) only is to be paid.
7.	What are the documents required to be submitted to claim the exemption ?	To avail the exemption, CAT Course Part I Marksheet/ CAT Certificate is to be submitted
8.	Do I need to submit documents and fees offline or online?	The documents and fees can be submitted online only at the link https://eicmai.in/studentfacility/Login.as px?ReturnUrl=%2fstudentfacility%2f
