- 3. CAT Course Part-I Examination will be conducted in **Multiple Choice Questions Mode through** offline **OMR based from Centre**.
- **4.** All candidates/students are encouraged to appear for the CAT Course Part-I Examination through the offline OMR-based format at designated centers.
- **5.** Each paper will consist of 100 Multiple Choice Questions, with each question carrying 1 mark, totaling 100 marks per paper. Each session will contain a total of 100 Multiple Choice Questions for 100 marks.
- **6.** There will be **no negative marking** for wrong answers.
- 7. Standard of Pass-A Candidate of CAT Course Part- I shall be declared to have passed in the Examination if he/she secures minimum 40% marks in each paper and an aggregate of 50% of total marks.
- 8. <u>Last date of receipt of Examination Application forms is 8th April, 2025 (Tuesday). There will be no extension in the last date of receipt of examination application forms for June 2025 examination.</u>
- **9.** A candidate/student who is completing all conditions for appearing in the examination as per Regulations will only be allowed to appear for the examination.
