4. **Candidates/Students are instructed to provide their own current in-use correct and updated contact details like mobile number and Email Id with all other required credentials. Otherwise student will not be permitted to apply/appear for the Examination. Candidates will receive Examination Link along with login user ID and pass key on their REGISTERED email id and mobile number only.**
5. Examination Pattern for CAT Course Part-I Examination shall have Multiple Choice Questions to be answered online from home. There will be no negative marking for wrong answers.
6. Standard of Pass - A Candidate of CAT Course Part- I shall be declared to have passed in the Examination if he/she secures minimum 40% marks in each paper and an aggregate of 50% of total marks.
7. All candidates/students are encouraged to appear in the CAT Course Part-I Examination through online mode using mobile/laptop/desktop/tab from their home.
8. A candidate who is fulfilling all conditions specified for appearing in examination will only be allowed to appear for examination.
