### RFQ for Appointment of Cost Auditor



Aavantika Gas Ltd. (AGL) is a Joint venture of GAIL & HPCL for implementation of City Gas projects in Indore, Ujjain, Pithampur & Gwalior for transportation, industrial, commercial and domestic consumers.

#### 1. SCOPE OF WORK:

# The brief scope of work of Cost Auditor for Three (03) Financial Years (2023-24, 2024-25, 2025-26) are as follows:

- Audit the Cost Record as per provision of company act & submit the reports.
- Prepare and File XBRL format of report.
- Complete all documentational formalities related to compliance to cost audit.

#### PAYMENT TERMS:

Fee will be paid on annual basis after submission of invoice duly certified by Officer-In-Charge.

#### 2. BID EVALUATION METHODOLOGY:

- I. Only Cost Accountant Firm / Proprietary Cost Accountant firm will participate.
- II. Bidders who have quoted the lowest fee (including out of pocket expenses, XBRL fees and taxes) will be awarded the assignment of cost audit for 3 years for the period of FY 2023-24, 2024-25 and 2025-26.
- III. If the quoted fee of two or more bidders are the same, the bidder who have more number of partners will be considered.
- IV. If the number of partners are also the same, the firm who has the oldest establishment will be considered.
- V. Quoted fees for 3 years cost audit should not be less than the minimum prescribed (Rs. 62,100 per annum excluding applicable GST). The quotation will be rejected if the fees are less than the minimum prescribed.

- I. Bidder to submit copy of the Firm Registration certificate / Membership Certificate/Member's Identity Card along with copy of Certificate of practice issued by Institute of Cost Accountant of India as qualifying document.
