**Call for Expression of Interest (EOI) from Chartered Accountant Firms / Cost & Work Accountants for Internal Audit of NGOs and Peripheral Units funded by Assam State Aids Control Society**

The Assam State AIDS Control Society is a registered society under the Societies Registration Act, 1860 which receives fund from Govt. of India under Domestic Budgetary Support for implementation of National AIDS Control Programs (NACP) in the State of Assam. ASACS releases fund to peripheral organizations and hospitals under government sector and NGOs. Hence to assess the proper utilization of fund by such peripheral organizations it is essential to conduct an internal audit of accounts of these units.

Expressions of Interest are invited from Cost & Works Accountant/ CAG empanelled Chartered Accountant firms to conduct the Internal Audit of NGOs & Peripheral Units under Assam State AIDS Control Society for the Financial Year 2023-24.

**Eligibility & Assessment Criteria:**


The EOI and capability will be assessed against evidence of skills and experience in providing accountancy services in the State.

**Requirements:**

The EOI should be sent along with a Capability Statement including a profile of the organization relevant technical and geographical coverage along with the financial turnover for the last 3 financial years. (A format for the Capability statement in Annexure – IX(b) is available in the ASACS website: <https://asacs.assam.gov.in> and <https://sppp.assam.gov.in/#/en> ) or may be obtained from ASACS Office during office hour. Individual CVs are not required at this stage. Any EOI with inadequate information, those which do not meet the above criteria, or those received after the closing date will not be short listed. EOI should be as concise and focused as possible to give evidence of the above requirements including the capability statement and organization profiles. They should be mailed to the Project Director, Assam State AIDS Control Society, Khanapara, Guwahati-781022 to arrive not later than 3 p.m. on 19<sup>th</sup> March, 2024. Only organizations, which pass the pre-selection process, will be contacted and invited to submit detailed proposals.
