

**EXPRESSION OF INTEREST FOR APPOINTMENT AS GOODS &  
SERVICE TAX AUDITOR**

Bharat Pumps & Compressors Limited (BPCL) (A Public Sector Undertaking under the control of Ministry of Heavy Industries & Public Enterprises, Government of India), was set up in the year 1970 at Naini, Allahabad. The company is engaged in manufacture and supply of heavy duty Pumps & Compressors and High Pressure Seamless and CNG Gas Cylinders/cascades to cater the needs of Oil exploration, refineries, petro-chemicals, chemicals, fertilizer and down stream industries.

The company has made a Turnover of Rs. 6866.29 lakhs in the Financial Year 2018-19 and is in the process of appointment of Goods & Service Tax Auditor for GST Audit in respect of three products viz.

1. Reciprocating Compressors - HSN 8413
2. Reciprocating/Centrifugal Pumps – HSN 8414
3. Gas Cylinders – HSN 7311/7308
4. Erection/Commissioning/Testing Services – SAC 9987

The appointment of the auditor shall be made in accordance with the provisions of Section 35(5) read with Section 44(2) of CGST Act, 2017 and rule 80(3) of CGST Rules in prescribed form GSTR 9C/Reconciliation with Annual Accounts alongwith the attachments as prescribed, for the Financial Year 2018-19. Such documents are to be submitted electronically through the GST Common Portal within the time limit specified in the GST Act.

**Eligibility Criteria:**

1. The firm may be a Proprietorship/Partnership Firm.
2. The firm shall ensure eligibility to be appointed as GST auditor in accordance with rules and provisions of GST Act and various guidelines issued by the respective Institutes of Chartered Accountants/Cost Accountants.
3. The Firm shall not be under disqualification enumerated in the Companies Act, 2013 in relation to appointment of auditor.

Accordingly Expression of Interest is invited from eligible firms of **Chartered Accountants/Cost Accountants** for appointment as GST Auditor for the financial Year 2018-19, in accordance with the rules of GST Act and ICAI guidelines, as applicable in relation to appointment of Auditor, alongwith the Audit Fees and copy of Profile of the Firm.
