b. Financial Bid:

The financial quote should be comprehensive but exclusive of statutory Tax like GST etc (If applicable). The Financial Bids will be opened for successful tenderers of Technical Bid. Estimated price of the Tender would be Rs. 4.80 lacs.

The Bids are to be submitted in 2 envelopes of Technical Bid & Financial Bid. Both the Bids of a firm are to be contained in one bigger envelop marked "OFFER FOR DOCUMENTATION, COMPILATION & CLOSURE OF ACCOUNTS OF CAMPA, WEST BENGAL".

5. OPENING BIDS:

Opening of Technical Proposal

i Technical proposals will be opened by the Tender Inviting Authority in the presence of Tenderer or his authorised representative.

ii Intending Bidders may remain present if they so desire in the office of the CAMPA, West Bengal at Aranya Bhawan, Block-LA-10A, Sector-III, Saltlake City, Kolkata-98 for opening of Technical Proposal, to be held on the date and time declared.

iii The technically qualified Bidders, i.e. Bidders who qualify in the assessment of the technical proposal, shall be eligible for competing the Financial Bid. Accordingly, the Financial Bids of only those Bidders who pass the Technical Evaluation shall be opened on the scheduled date and time.

6. NORMS FOR FINALISATION OF THE BIDS:

The Evaluation of the tender will be done based on the Principle of Quality cum Cost Based Selection (QCBS) and Experience of the firm along with their experience on Accounting in Forestry Operation.

The details of the process are described below:

The evaluation of the proposal shall be carried out in two stages.

In the first stage, evaluation of the technical proposal will be taken up. Proposals which are received unsigned, or are incomplete (i.e. when the required bid formats and /or supporting documents have not been submitted along with Covering letter), will be summarily rejected as non-responsive.

In the second stage, evaluation of the financial proposal of the technically qualified bidders will be taken up.

The weightage assigned for bids is Technical bids: Financial Bids = 70:30. The final assessment will be based on the 70% of Technical + 30% of Financial scores.

7. Evaluation of Technical Bids

The Technical Bid will be evaluated on the basis of the following criteria:-

8. Bidders securing Technical score of 60 or above, will qualify for the evaluation in the financial bid. In exceptional circumstances, to be recorded in writing, the Evaluation authority may recommend lower/higher qualifying marks.

9. OPENING AND EVALUATION OF FINANCIAL PROPOSAL:

Financial proposals of the Bidders declared technically eligible will be opened.

10. Evaluation of Financial bids

The financial Bids of the technically qualified bidders will be evaluated as per the evaluation criteria mentioned below:

- The maximum Financial score for evaluation of financial bids is 100
- The list of Bidders will be ranked in ascending order, i.e. the Bidder who quoted the lowest amount (L1) will be ranked first and so on. For the purpose of this tender the participating bidder who would quote the lowest gross amount as Financial quote, will be ranked L1 and will be assigned 100 marks. Other bidders, viz: L2, L3 etc. will be compared against the financial quote of the L1 and marks assigned accordingly. For example, if the quote of L1 is Rs.200/- and that of L2 is Rs.400/-, then L1 will be awarded 100 marks (maximum) and L2 will be awarded (200/400)x100 = 50 marks.

Total Score Secured = 70% of Technical Score + 30% of Financial Score

11. AWARD OF CONTRACT AND ISSUE OF WORK ORDER:

After selection of the successful bidder, a Letter of Acceptance of tender will be issued to the successful bidder by the Tender Inviting Authority. The successful bidder should submit an acceptance within two week from the date of receipt of the Letter of acceptance issued by competent authority. If the same is not executed within two week, the tender may be held as non-responsive. In case the first successful bidder does not accept the assignment then the bidder with second highest score may be offered the Letter of Acceptance. Work Order will be issued to the successful bidder after receipt of the acceptance from the successful bidder.

12. DURATION AND EXTENTION OF WORK ORDER

The work order for the arrangement will initially be for one year from the date of signing, which would be extendable under the same terms and conditions by one more year, based on performance, on yearly basis. An escalation of cost to the tune of 10% shall however be admissible, calculated over the base cost of present tender.
