Chhattisgarh Railway Corporation Limited (CRCL), a Joint Venture of Ministry of Railways and Govt of CG with equity participation of 49:51, has a mandate of developing bankable Railway project in the state of Chhattisgarh. CRCL invites sealed quotations from qualified and experienced Chartered Accountant firms / Cost Accountants firms for Appointment of Internal Auditor for the Financial Year 2025-26 under section 138(1) of the Companies Act, 2013 (Budgetary Offer of Rs.55000/ plus applicable tax for each year) as per the terms & conditions mentioned below.

The sealed quotations along with all the required document must reach in the office of the Managing Director / CRCL on or before **28/01/2026 (Time: - 15:00 Hrs)**

The quotations will be opened on the same day **28/01/2026 (Time: - 16:00 Hrs)**

Terms & Conditions: -

- a) Envelope should be super-scribed "Quotation for Appointment of the Internal Auditor to CRCL, Raipur. Quotations need to be submitted by speed post/registered post/hand delivery in office of **Chhattisgarh Railway Corporation Limited, 1st Floor, CSIDC Commercial Complex, Mahadev Ghat Road, Raipura Chowk, Raipur, Chhattisgarh-492013**. The quotations received after the deadline shall not be entertained under any circumstances whatsoever. In case of postal delay CRCL will not be held responsible.
- b) Unsealed quotation will be rejected.
- c) Quotations must be submitted in the enclosed prescribed Proforma (Annexure-I) along with declaration (Annexure-II) and with forwarding letter on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, in case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation.
- d) Rates must be quoted as per the format specified, taxes extra, if any must be



written separately. The rates must be quoted in figures as well as in words. In case of find error in fighters then CRCL, will accept only rate quoted in words.

- e) In general, No overwriting or cutting is permitted in the rate.
- f) Becoming lowest (L1) will not be the criteria for awarding of the work unless the rates are reasonable & justified. L1 will be decided for the overall value of quotation and not item wise.
- g) RTGS/NEFT details need to be furnished by the firms with the quotation on the letter head of firm.
- h) The firm may satisfy the following conditions and attach self-attested copy of the same with the quotation:

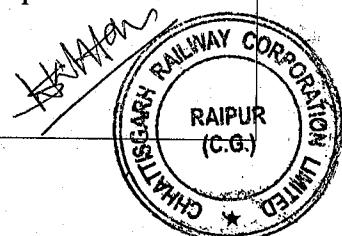

A-Scope of work (Internal Audit)

1. Carry out Internal Audit of Accounts for the Financial Year 2025-26.
2. Check all the transactions Pertaining to cash, Bank Journal, Payments, Receipts, with reference to the supporting documents/entries & authorization etc.
3. Conduct the physical verification of cash as well as fixed assets and scrap of unused assets and items, check the assets register.
4. Review the system of keeping cheque books & issue of cheques.
5. Comment on the system of withdrawal of cash from the bank with reference to the security arrangement in transit and in the offices and on unutilized funds in bank accounts.
6. Check and comment whether tax at source as required is correctly deducted from the payment made to Contractors, Salaries, Professional Services/ Firms, rent, Service providers, Consultants etc. and whether TDS so deducted is being deposited in time
7. Comments on timely submission of Returns as required by law & issue of TDS certificates, Check the receipts of TDS certificate towards TDS deducted by others.
8. Conduct scrutiny of General Ledger and Staff Advances / Staff imprest, reconcile all advances such as Tour advance etc.
9. Verification of BG's submitted by contractor's and comments on timely renewal.
10. Scrutiny of EMD, Tender, various policies adopted by the company and comment.
11. To Prepare
 - A- Monthly Bank Reconciliation Statement and scrutiny thereof, suggesting necessary entries to be incorporated
 - B- Quarterly/Annual Final Trial Balance for the year after passing necessary adjustment entries, Balance sheet, Profit & Loss Account along with all necessary Schedules and Annexure

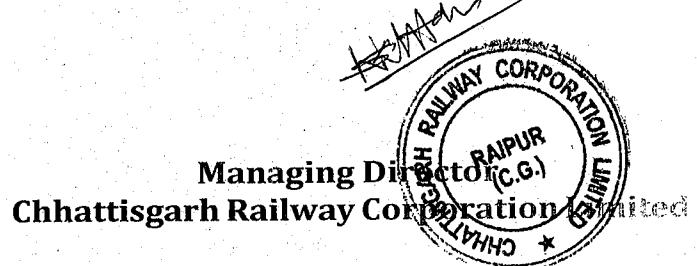
Mode of Payment:-
