## **Technical Evaluation Criteria**

<u>Note:</u> (1) Firms meeting the above minimum eligibility criteria shall furnish requisite copies of documents, self declaration, certificates, work order, completion certificate from the respective bodies/offices, ITR, Balance Sheet, statement of Profit & Loss etc. in support as asked above.

(2) It is to be noted the requirements stated above at point 1, 2, 3, 7 & 8 are essential parameters, failing which, the bid will be rejected in the Technical Evaluation stage.
