- Hindustan Copper Limited (HCL), a public sector undertaking under the administrative control of t he Ministry of Mines, Government of India, having its registered office at Tamra Bhawan, 1, Ashutos h Chowdhury Avenue, Kolkata – 700019, invites online bids through GeM Portal from practicing Cha rtered Accountant/Cost Accountant or a Firm / LLP of Chartered Accountants/Cost Accountants regis tered with the Institute of Chartered Accountants of India/the Institute of Cost Accountants of India, meeting the pre-qualification criteria as stipulated below, for empanelment to conduct Internal Audi t in respect of (i) HCL Corporate Office (CO), Kolkata (West Bengal) & Indian Copper Complex (ICC), Ghatsila (Jharkhand), (ii) Khetri Copper Complex (KCC), Khetri Nagar (Rajasthan), (iii) Malanjkhand Copper Project (MCP), Malanjkhand (Madhya Pradesh), (iv) Taloja Copper Project (TCP), Taloja (Ma harashtra), and (v) Gujarat Copper Project (GCP), Jhagadia (Gujarat), from which 5 Audit Firms will be selected initially for a period of one FY (2023-24) with provision for extension of two further ter ms of one FY each, subject to satisfactory performance at the sole discretion of HCL at same rate, t erms and conditions. INSTRUCTIONS TO BIDDERS

1. Communication:

The bidder must provide complete address, fax number, corporate e-mail id and mobile number.

2. Cost of Bidding:

The bidder shall bear all costs associated with the preparation and online submission of bid and the Company will in no case be responsible or liable for those costs, regardless of the conduct or out come of the bidding process.

3. Extension of due date of Tender.

HCL reserves the right to extend the due date of tender as deemed fit by issue of corrigendum thro ugh HCL website and GeM Portal.

4. Language:

The language of the bid shall be English. All documents enclosed should also be in English languag e. In case the original document is in a different language, self-attested English translation with sig nature and stamp of the authorized signatory of the bidder shall have to be furnished.

5. Letter of Bid (LOB):

The format of Letter of Bid (LOB) as mentioned below will be downloaded by the bidder and will be printed on Bidder's letter head and duly Signed by a person competent and having the "Authority"/

"Power of Attorney" to bind the bidder. Scanned copy of such a "Signed & Stamped with the seal of the company" LOB along with "Authority"/ "Power of Attorney" is to be uploaded during bid submis sion. This will be the covering letter of bidder for the submitted bid.

The content of the "Letter of Bid" uploaded by the bidder must be the same as per the format dow nloaded from website and it should not contain any other information. If there is any change in the contents of Letter of Bid uploaded by bidder as compared to the format of Letter of Bid uploaded b y HCL with NIT document, then the bid may be liable for rejection.

6. Evaluation of Bids:

- (i) After opening of the bid, the documents submitted by firms will be downloaded and shall be p ut up to the evaluating Committee. The Committee will examine the uploaded documents agai nst information/declarations furnished by firms online. If it confirms to all of the information/de clarations furnished by the firm online and do not change the eligibility status of the firm, then t he firm will be considered eligible for next level.
- (ii) Bids which have not been submitted with valid documents will not be considered for further ev aluation.
- (iii) After evaluation of the uploaded documents, shortfall documents, if required, shall be sought fr om the bidders by the evaluation Committee. The Firm will get this information through E-mail id/Gem Portal.

It will be the Firm's responsibility to check the updated status/information in their e-mail/GeM P ortal after opening of bid. No separate communication will be made in this regard. Non-receipt of e-mail/GeM Portal will not be accepted as a reason of non-submission of documents within t he prescribed time. The firm will upload the scanned copy of all those specified documents in s upport of the information/ declarations furnished by them online within the specified period.

- (iv) The offers will be evaluated in accordance with the criteria mentioned below (Bid Evaluation Criteria for engaging Internal Auditors for HCL Units & Offices) on the basis of docume nts uploaded by firm online. The firm is not required to submit hard copy of any document thro ugh offline mode. Any document submitted offline will not be given any cognizance in the evaluation of offer.
- (v) In case the Firm fails to submit requisite documents online as per tender document or if any of the information/declaration furnished by firm online is found to be wrong by Committee during evaluation of scanned documents uploaded by firm, which changes the eligibility status of the f irm, then his bid shall be rejected.
- (vi) It is responsibility of Firms to upload legible/clearly readable scanned copy of all the required d ocuments as mentioned above.
- 7. HCL reserves the right to verify the documents uploaded by the firm with the original, if necessary. Bidder has to submit the originals to HCL on demand.
- 8. The offer should be submitted strictly as per the terms & conditions laid down in the Bid documen t, failing which the offer will be liable for rejection. 1. Location-wise Half Yearly Fee to Audit Firms:

Lead Audit Firm will be paid an additional fee of Rs. 15,000/- per half yearly (Rs.17700 includi ng GST))audit period of six (6) months for consolidation of all location-wise audit reports along with preparation of an executive summary for giving power point presentation before HCL Boar d Audit Committee. **All Applicable GST will be paid extra as per laws.**

Note:

IV. 2. Travelling Allowance:

Partner/Qualified CA of the Audit Firm shall be entitled for rail fare by AC II Tier/AC Chair Car (w herever applicable from the nearest railway station), and Semi-qualified assistant by AC III Tier/A C Chair Car (wherever applicable from the nearest railway station) on submission of proof of jour ney. For this purpose, journey will be considered from the Firms' nearest office as per **Para C of Annexure-III** to the place of audit. In case of journey by mode other than rail, TA will be limited to entitled class or actual fare, whichever is lower, subject to production of documentary eviden ce.

The Partner of the Lead Auditor shall be entitled for economy air fare/1 st AC rail fare for attending & giving power point presentation before the Audit Committee meeting at the end each half y early audit period (date of which shall be intimated by HCL) on submission of proof of journey.

3. Boarding, Lodging & Local Transport:

The Audit team will be provided with free boarding, lodging at Company Guest House at all locat ions where such facility is available. The Audit team will be provided local transport facility at H CL Units.

4. Payment of Internal Audit Fee:

Payment of Audit Fees and travelling expenses will be released phase-wise after submission of the reports for that phase and conclusion of Audit Committee meetings for accounts ending 30^t ^h September and 31st March of respective FY. The respective Audit Firms shall submit their bills in original along with all supporting documents, certified copies of attendance sheet of audit tea ms and stay certificate issued by the Units/CO/RSOs of HCL, as the case may be, to the respecti ve Units/Offices who will in turn verify the bills and submit the same to Internal Audit Departme nt at Head office, Kolkata for release of payment.

FORCE MAJEURE CLAUSE:

If at any time during the continuance of this contract, the performance in wh ole or in part by either party of any obligation under this contract shall be pr evented or delayed by reason of war, act of hostility of public enemy, civil di sruption or sabotage, fires, floods, explosions, epidemics, guarantine restricti ons, strikes, lock-outs or acts of God (here-in-after referred to as events), pro vided notice of the happening of any such eventuality is given by the either p arty to the other within 21 days from the date of occurrence thereof, neither party shall by reasons of such event be entitled to terminate this contract no r shall either party have any claim for damages against the other in respect of such non - performance or delay in performance/execution under the cont ract. Provided also that such performance/execution under the contract sh ould commence as soon as practicable, after such event has come to an end or ceased to exist, and the decision of HCL as to whether the performance ha s been so resumed or not shall be final and conclusive. Provided further that if the performance in whole or in part or any execution under this contract is prevented or delayed by reasons of any such event for a period exceeding 6 0 days, either party may opt to terminate the contract. If the contract is term inated under this clause, HCL shall have liberty to take over from the contrac tor at a reasonable price, all unused, undamaged and acceptable materials, machinery, equipments, etc. at the site, being used for the performance of th e contract and in the possession of the contractor at the time of such termina tion of such portion thereof as HCL may deem it fit, except such materials, e quipments, etc that the contractor may with the concurrence of HCL elect to retain. It is also understood in addition that this force Majeure clause will cov er parties' inability to perform on account of change in law or imposition of ru les or restrictions by the Government.

ARBITRATION:

Any dispute(s) of difference(s) of any kind whatsoever arising between the parties out of, or re lating to the construction, meaning, scope operation or effect of the contract or its validity or its breach thereof, if not settled mutually, shall be referred by the parties to this contract for Arbitra tion under the Arbitration and Conciliation Act, 2015 and the provisions there under, and the aw ard made in pursuance thereof shall be binding on the parties.

The Arbitrator will be appointed within 30 days of reference to arbitration. A Sole Arbitrator will I be nominated by the Chairman-cum-Managing Director of Hindustan Copper Limited (HCL), wh o, according to the 2015 Act, will not stand in conflict of interest with any to the organizations. A declaration to the effect shall be submitted by the Arbitrator, to guarantee impartially in the pro ceedings. In case of a dispute of very high value, the dispute may be referred to an arbitral tribu nal, consisting of an Arbitrator nominated by both parties each and one arbitrator appointed by both the above arbitrators.

In the event of such an arbitrator to whom the matter is originally referred, being transferred o r has vacated his office because of retirement, or resignation or otherwise or refuses to act or is incapable of acting for any reason whatsoever, the Chairman-cum-Managing Director of HCL shal I appoint another person to act as arbitrator in his place, who again would not stand in any confli ct of interest with both the parties. Such person(s) shall be entitled to proceed from the stage at which his predecessor left it.

The duration of proceedings and the fee structure will be governed by the 2015 Act. The venu e of the arbitration shall be Kolkata only. The award of the arbitrator shall be final and binding o n the parties. Any dispute, which arises at any point of time out of arbitration, shall have the juri sdiction of the court of Kolkata, West Bengal.

Subject to the above, the provision of Arbitration and Conciliation Act, 1996 and the rules ther e under and the statutory modifications thereof shall govern such arbitration proceedings and sh all be deemed to apply and be incorporated in this contract.

JURISDICTION OF THE COURT:

Only the Court of Kolkata, West Bengal having original jurisd iction to entertain suit shall have jur isdiction to receive and decide any application/applications under the Arbitration and Conciliatio n Act, 1996 and no other court shall have any jurisdiction whatsoever.

APPLICABLE LAWS:

The Indian Acts will be applicable in all matters.
