BRIEF INTRODUCTION AND GENERAL INFORMATION:-

- 1. Indian Statistical Institute (ISI) is an academic institute of national importance. ISI functions under the Ministry of Statistics and Program Implementation, Govt. of India. Detailed profile of ISI Delhi Centre may please be browsed from URL www.isid.ac.in.
- 2. The bidder has to carry out GST Compliance Audit of **ISI Delhi Centre** for the FY 2017-18.
- 3. The bidder will complete the GST Compliance Audit of ISI Delhi Centre where books of accounts are being maintained.
- 4. The audit of the Centre has to be conducted immediately on award of contract and report will have to be submitted on or before 15th December 2018.
- 5. The bidder has to ensure the compliance of all statutory and regulatory provisions as defined under GST Act/ Rules.
- 6. Bidder has to provide its GST Compliance Audit report, Annual Return and reconciliation statement GSTN wise strictly as per the proforma provided in concerned Act.
- 7. Bidder has to verify each voucher/transaction as well as tax credit of transitional period along with its relevant documentary evidence and ensure that all the transactions are properly accounted for in the books of accounts as per the GST Act/ Rules and ITC has been availed/utilized properly.
- 8. Bidder has to reconcile the monthly output liability of GST and claim of input tax credit computed by ISIDC including exercise of matching of input tax credit as per FORM GST 2A with the accounts.

- 9. The Bidder will be required to conduct the annual GST Compliance audit as required under Section 35(5) of CGST Act and file the Annual Return electronically in such form and manner as prescribed under the concerned GST Act/Rules.
- 10. Any Liability arising vis-à-vis late fee due to non-filing of annual return as per Section 44 within due date shall be borne by the Auditor. However, if the delay is on the part of ISIDC, the same shall be borne by ISIDC. Any other work related to GST Compliance Audit as well as reconciliations during the period of the contract will be carried by the bidder.
- 11. In addition to professional fees, ISIDC will not provide any TA/DA/conveyance, accommodation charges, out of pocket charges etc.
- 12. **Payment Terms:** 100% Payment will be released to the successful bidder on completion of the Audit work and acceptance thereof by the centre.
