As per the above rate contract agreement terms and conditions the suppliers are allowed to add additional brands subject to a maximum by submitting fresh quotation and remitting applicable EMD, Tender But the condition is now amended in the way that, the existing suppliers be allowed to add additional brands by remitting a minimum per Rs.25000 per brand subject to the overall limit of 20. The Certificate authenticated by Chartered Accountant, BOQ, brand ownership details should be submitted along with penalty. In the case of FMFL and FM facility will be applicable to the already approved foreign manufacturers through their Authorized Agents/Distributors in India.
