This envelope should be submitted physically until date of submission and opening against the Tender. Tenders received within specified time (e-Tender as well as physical submission) shall only be opened at 16.00 Hrs. on the date specified against Tender in presence of the Tenderer or their authorized representatives, whosoever may be present.

[4] Documents required for participation in Tender.

- (i) The prospective bidders, who have adequate documents to fulfill criteria of credentials will upload scanned self certified copies of requisite documents as required in e-Tendering process.
- (ii) **Those physically submitted documents will be acceptable and considered, if, same are uploaded on the website along with Tender offer. Cognizance of other physically submitted documents (if any) shall not be taken.**
- (iii) First of all the physically submitted envelope of credentials/TENDER documents will be opened. The offers received without pre requisite credential /TENDER documents shall not be considered further for opening of their e-Tender. Decision of MPPGCL in this respect shall be final.
